At last fall's Board of County Commissioners public hearing, the Gleneagle Golf Course Residential Infill Development – Filing 1 earned approval. An area encompassing 12 residential lots was deferred for public hearing by the BoCC until unresolved drainage easement issues with existing adjacent property owners to the west of the Gleneagle Golf Course property on Westchester Drive could be addressed satisfactorily.
