PERMIT TO USE AN EXISTING WELL

ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT **CONDITIONS OF APPROVAL**

- This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of this permit does not 1) ensure that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- The construction of this well shall be in compliance with the Water Well Construction Rules 2 CCR 402-2, unless approval of a 2) variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 18.
- Approved pursuant to CRS 37-90-105 for a change of use of an existing well, constructed under permit no. 284649, on a tract of 3) land of 20 acres described as a the W1/2 of the SE1/4 of the SW1/4 of Section 23, Township 12 South, Range 64 West of the Sixth P.M., El Paso County, for one well to be used in one commercial business described as a dog kennel/training facility. The business must meet the qualifications as described in CRS 37-90-105(1)(c)(II). Use of this well in a commercial business having another small capacity commercial well is prohibited unless a new permit to use this well is granted.
- Water from this well may be used for domestic purposes inside 1 single family dwelling, and the irrigation of not more than 4) 12,000 square feet of lawn and garden.
- 5) The pumping rate of this well shall not exceed 15 GPM.
- The annual withdrawal of ground water from this well shall not exceed 1 acre-foot. 6)
- Production is limited to the Denver aquifer which is located 255 feet below land surface and extends to a depth of 1025 feet. 7) Plain casing must be installed and grouted to prevent the withdrawal of ground water from other aquifers and the movement of ground water between aquifers.
- This well shall be located within 300 feet of the location specified on this permit. 8)
- A totalizing flow meter must be installed on this well and maintained in good working order. Permanent records of all diversions must be maintained by the well owner (recorded at least annually) and submitted to the Upper Black Squirrel Creek Ground Water Management District and the Division of Water Resources upon request.

NOTE: The ability of this well to withdraw its authorized amount of water from this non-renewable aquifer may be less than the 100 years upon which the amount of water in the aquifer is allocated, due to anticipated water level declines.

NOTE: This well is located within the Upper Black Squirrel Creek Ground Water Management District where local District Rules apply which may further limit the withdrawal and use of designated ground water as authorized under this permit.
