## Fire Prevention Division Fire Protection Report for Planning

The Department: The Cimarron Hills Fire Department fire station is located at 1885 Peterson Road and protects an area of 6.4 square miles. The estimated emergency response time is approximately 5 minutes to any location within the district. The fire department currently has (24) full time fire and emergency medical personnel supported by 5 administrative staff members. All personnel are trained to the EMT-Basic Level and 7 are Advanced Life Support capable. In addition, there are (12) part time fire and emergency medical personnel.

Apparatus: (1) 75' Aerial Fire Apparatus 1,500 GPM; (1) 1500 GPM Engine; (2) Brush Truck/Light Rescues; (1) Advanced Life Support Ambulance and (3) support/command vehicles. Initial response will consist of the Aerial Ladder, Light Rescue, ALS Ambulance, and a Chief Officer. Mutual Aid is provided initially by Falcon Fire with an additional Engine. Colorado Springs will send 2 Engines, 1 Ladder, and a Chief Officer to all working commercial structure fires.

Services: Cimarron Hills Fire Department provides all emergency and non-emergency responses. CHFD also provides all construction plan reviews, fire final inspections, and code enforcement within our jurisdiction. As of July 1, 2022, Cimarron Hills Fire District was classified as a Class 2 Protection Class by the Insurance Service Office.
