Background

Silverado Ranch is a rural equestrian-oriented PUD of 64 2.5-acre minimum lots southeast of Schriever AFB, bordered on the north by Drennan Road and on the west by Peyton Highway. The PUD zoning and Preliminary Plan were approved in 2008. The Final Plat for Filing No.1 (10 lots) was approved in 2018 and is approximately 50 % built out. Silverado Ranch SRF2 (SRF2) will add 15 lots to the east of the 10 lots in Filing 1. Silverado Hill View, the existing main subdivision road, will be extended to the east to provide access to the 15 new lots.

Adequate Water Supply

Required Water Quality Information

Water samples were taken on June 3, 2024 and provided to El Paso County Public Health Department the same day for chemical analyses. Chemical analyses were conducted on June 4, 2024. The results for the two tests are attached herein as Exhibit B. All test results were within acceptable EPC and State standards.

(3) Discussion of potential for water quality degradation from onsite and off-site sources.

The applicant makes the following statement: "There are no known sources, on adjacent properties or within the subdivision, of surface water that could leach into the ground to the depth of the Laramie-Fox Hills aquifer. All homes in the area are supplied by wells from the aquifer."
