This letter is being sent to you because Lorson LLC is proposing a land use project in El Paso County located within the south-central portion of Lorson Ranch, between the Jimmy Camp Creek Main Channel and the Jimmy Camp Creek East Tributary. This information is being provided to you prior to a submittal with the El Paso County Planning and Community Development Department. Please direct any questions on the proposal to the referenced contact(s) as listed below. Prior to any public hearing on this proposal a notification of the time and place of the public hearing will be sent to the adjacent property owners by the El Paso County Planning Department. At that time you will be given the El Paso County contact information, the file number and an opportunity to respond either for, against or expressing no opinion in writing or in person at the public hearing for this proposal.

The proposal being submitted to El Paso County is seeking approval of a final plat to create 235 lots approved with the Creekside at Lorson Ranch Planned Unit Development Plan (PUD) and a Preliminary Plan. The site is zoned to allow single family residential development at a density of 7-10 DU/ Acre. The proposed project contains 235 single family detached units on 83.08 acres for a gross density of 2.83 dwelling units per acre. The site is suitable for the intended use of single family residential and is compatible with both the existing and allowed land uses found throughout Lorson Ranch.


The site is undeveloped land with native grasslands and rolling topography. There is an existing detention facility that shall remain which is currently owned and maintained by the Lorson Ranch Metropolitan District. There also exist an 80' FMIC Ditch easement and pipeline that shall remain. The proposed development will not interfere with the detention facility or the FMIC Ditch easement.
