Augmentation Plan approved by the Division 2 Water Court in case no. W-4568. If this well is not operated in accordance with the terms of said decree, it will be subject to administration including orders to cease diverting water.
- Approved for a well on a residential site of 0.70 acre described as Lot S-276, Filing 2, Crystal Park Subdivision, El Paso County. 4)
- The use of ground water from this well is limited to ordinary household purposes inside one single family dwelling. The ground 5) water shall not be used for irrigation or other purposes.
- The maximum pumping rate of this well shall not exceed 15 GPM. 6)
- The maximum annual consumptive use of groundwater from this well, in combination with all other wells constructed pursuant 7) to Division 2 Water Court case no. W-4568 shall not exceed 13 acre feet per year.
- The return flow from the use of this well must be through an individual waste water disposal system of the non-evaporative type 8) where the water is returned to the same stream system in which the well is located.
- 9) A totalizing flow meter must be installed on this well and maintained in good working order. Permanent records of all diversions must be maintained by the well owner (recorded at least annually) and submitted to the Division Engineer upon request.
- This well shall be located not more than 200 feet from the location specified on this permit. 10)

NOTE: This permit has been approved subject to the following changes: the full name of the subdivision is Crystal Park Christian Community. You are hereby notified that you have the right to appeal the issuance of this permit, by filing a written request with this office within sixty (60) days of the date of issuance, pursuant to the State Administrative Procedures Act. (See Section 24-4-104 through 106, C.R.S.)

NOTE: This permit will expire on the expiration date unless a pump is installed by that date. A Pump Installation and Test Report (GWS-32) must be submitted to the Division of Water Resources to verify the well has been constructed and the pump has been installed. A one-time extension of the expiration date may be available.
