- C. Declarant executed and caused to be recorded that certain Second Supplement to Declaration of Covenants, Conditions and Restrictions for STONEBRIDGE FILING NO. 1 AT MERIDIAN RANCH, Lots 1-102 (Annexation of Stonebridge Filing No. 3 at Meridian Ranch), recorded November 21, 2017, under Reception No. 217141480 of the records of the Office of the Clerk and Recorder of El Paso County, Colorado (the "Second Supplement")

3. <u>Effect of Annexation</u>. The Annexable Property described in Exhibit A, and the Lots identified therein, shall be deemed to be included within the Property covered by the Declaration and subject to all of the terms, provisions, covenants, conditions, reservations, charges, and liens set forth in the Declaration, including all assessment obligations set forth in the Declaration. The Annexable Property described in Exhibit A and the Lots identified therein are also expressly subject to all of the provisions of the Articles of Incorporation and the Bylaws of the Stonebridge Homeowners Association, as more particularly described in the Declaration, the Articles of Incorporation, and the Bylaws.
