The mention of 3 exterior designs threw me off guard with me thinking I needed three different drawings:). I found the application and I do have appropriately sized doors on the front for livestock etc. I understand now we have the cupola and the siding material and you need a third. Do you know what a barn breezeway constitutes? Along with the large door on the front, we have two side windows and a side door to ensure animals take advantage of the breeze. Also the bottom is raised with air coming under walls.
