•BASIS OF BEARINGS: THE TANGENT OF THE SOUTIIWESTERLY RIGHT OF WAY LINE OF AN 80.00 FOOT WIDE COUNTY ROAD, AS DESCRIBED IN BOOK 3092 AT PAGE 155 OF TIH EL PASO COUNTY RECORI}S, BEING MONURENTED AT EACH END WITH A NO. 4 REBAR AND P YELLOW PLASTIC SUVERYOR'S CAP MARKED ``K&W 3854" IS ASSUMED TO BEAR SOUTH 64° 05' 39" EAST, A DISTANCE OF 1637.51 FEET.
