The use limitation in the conditions of approval of the subject well permit, issued prior to May 17, 1988 Pursuant to Section 37-92-602(3)(b)(II) CRS 1973, is hereby amended pursuant to Section 37-92-602(3)(b)(II)(B), CRS as follows:

THE USE OF GROUND WATER FROM THIS WELL IS LIMITED TO ORDINARY HOUSEHOLD PURPOSES INSIDE A SINGLE FAMILY DWELLING AND THE WATERING OF THE USER'S NON-COMMERCIAL DOMESTIC ANIMALS. THE GROUND WATER SHALL NOT BE USED FOR IRRIGATION OR OTHER PURPOSES.

INSTRUCTION SHEET  
APPLICATION TO AMEND THE USE OF A HOUSEHOLD USE ONLY WELL PERMIT  
TO ALLOW THE WATERING OF NON-COMMERCIAL DOMESTIC ANIMALS

PURSUANT TO HOUSE BILL 1111, SIGNED INTO LAW ON MAY 17, 1988, CRS 1973 37-92-602 (3)(b)(II) WAS AMENDED. THIS IS THE APPLICATION FORM TO AMEND AN EXISTING PERMIT ISSUED FOR HOUSEHOLD USE ONLY PURPOSES TO INCLUDE THE WATERING OF THE USER'S NON-COMMERCIAL DOMESTIC ANIMALS. THE AMENDED STATUTE APPLIES ONLY TO "HOUSEHOLD USE ONLY" PERMITS OUTSIDE OF A DESIGNATED GROUND WATER BASIN. IT DOES NOT APPLY TO WELL PERMITS ISSUED PURSUANT TO A PLAN FOR AUGMENTATION. THE STATUTE DOES NOT ALLOW ANY OTHER OUTSIDE USE EXCEPT THE WATERING OF DOMESTIC ANIMALS. IN ORDER TO AMEND YOUR PERMIT, YOU MUST SUBMIT THE COMPLETED APPLICATION ON THE REVERSE SIDE. THE FOLLOWING INFORMATION WILL BE REQUIRED.

**FILING FEE:**

The filing fee for this application to amend is \$25.00. A check or money order payable to the State Engineer MUST be submitted with the application and is not refundable.

**WELL PERMIT NUMBER:**

This application must identify the well by permit number. The permit number is found in the lower right hand area on the front page of the well permit.

**COPY OF THE PERMIT:**

To assure that the proper permit is amended, a copy of the front of the permit must be attached to this application. Copies may be obtained from the Information Services Branch of the State Engineer's Office for \$0.50.

A COPY OF THE ORIGINAL PERMIT (FRONT PAGE) MUST BE ATTACHED TO THIS APPLICATION BEFORE IT CAN BE EVALUATED.

If acceptable, a copy of the approved amendment form will be sent to the mailing address provided. The original becomes part of the permanent records of this office.
