DEVIATION REQUEST (Attach diagrams, figures, and other documentation to clarify request)

A deviation from the standards of or in Section 2.5.2.(C3) of the Engineering Criteria Manual (ECM) is requested.

Identify the specific ECM standard which a deviation is requested:

Pedestrian ramps at "T" intersections.

State the reason for the requested deviation:

Allow only two pedestrian ramps to be constructed at the T-intersection of Salem Court and Waterbury Drive.

Explain the proposed alternative and compare to the ECM standards (May provide applicable regional or national standards used as basis):

The proposed alternative is to construct two pedestrian ramps crossing Waterbury Drive and no ramps crossing Salem Court at this T-intersection. The ECM standard is for T-intersections to have a minimum of three curb ramps.

Provide justification:

The intersection is in close proximity to another intersection with all the required ramps constructed. The installation of an additional ramp at this intersection is not desirable since the additional ramp may be a safety concern as the removed crossing does not have a stop condition and is further down a long straightaway roadway without traffic calming. As stated in ADA federal guidelines, a curb ramp is required wherever a sidewalk crosses a curb. Having no 3rd sidewalk crossing at the described intersection and providing a safer crossing at an intersection within 150' does not conflict with ADA standards. At the location of the requested deviation, the crosswalk markings would also need to be heavily angled to avoid proposed drainage infrastructure and adjacent proposed driveways. Heavily angled crosswalks are less desirable as perpendicular or near-perpendicular crossings. The crossing at Merchant Royal Loop and Salem Court is approximately 150' feet away and provides a much safer intersection for pedestrian movements.

The standard does not impose any particular hardship on the applicant. However, it will be more beneficial to pedestrian continuity and public safety.

CRITERIA FOR APPROVAL

Per ECM section 5.8.7 the request for a deviation may be considered if the request is **not based exclusively on financial considerations**. The deviation must not be detrimental to public safety or surrounding property. The applicant must include supporting information demonstrating compliance with **all of the following criteria**:

The deviation will achieve the intended result with a comparable or superior design and quality of improvement.

Elimination of one of the three ramp crossings at this intersection will not impede pedestrian movements and will result in safer pedestrian crossing due to safety concerns. A pedestrian will be able to cross at an alternate location within approximately 150' of the eliminated ramps.

The deviation will not adversely affect safety or operations.

Elimination of one of the three ramp crossings at this intersection will not impede pedestrian movements and will result in safer pedestrian crossing due to safety concerns. A pedestrian will be able to cross at an alternate location within approximately 150' of the eliminated ramps. The alternate crossing is controlled by a stop condition.

The deviation will not adversely affect maintenance and its associated cost.

Maintaining fewer pedestrian ramps will be less expensive.

The deviation will not adversely affect aesthetic appearance.

Fewer pedestrian ramps will not visually affect the intersection's appearance nor prevent adequate, safe pedestrian movements.

The deviation meets the design intent and purpose of the ECM standards.

The deviation will meet the design intent and purpose of the ECM as elimination of one ramp crossing at the intersection will not impede pedestrian movements and will result in safer pedestrian crossing.

The deviation meets the control measure requirements of Part I.E.3 and Part I.E.4 of the County's MS4 permit, as applicable.

Water quality requirements will be met regardless of pedestrian ramp elimination.

ECM ADMINISTRATOR COMMENTS/CONDITIONS:

1.1. PURPOSE

The purpose of this resource is to provide a form for documenting the findings and decision by the ECM Administrator concerning a deviation request. The form is used to document the review and decision concerning a requested deviation. The request and decision concerning each deviation from a specific section of the ECM shall be recorded on a separate form.

1.2. BACKGROUND

A deviation is a critical aspect of the review process and needs to be documented to ensure that the deviations granted are applied to a specific development application in conformance with the criteria for approval and that the action is documented as such requests can point to potential needed revisions to the ECM.

1.3. APPLICABLE STATUTES AND REGULATIONS

Section 5.8 of the ECM establishes a mechanism whereby an engineering design standard can be modified when if strictly adhered to, would cause unnecessary hardship or unsafe design because of topographical or other conditions particular to the site, and that a departure may be made without destroying the intent of such provision.

1.4. APPLICABILITY

All provisions of the ECM are subject to deviation by the ECM Administrator provided that one of the following conditions is met:

- The ECM standard is inapplicable to a particular situation.
- Topography, right-of-way, or other geographical conditions or impediments impose an undue hardship on the applicant, and an equivalent alternative that can accomplish the same design objective is available and does not compromise public safety or accessibility.
- A change to a standard is required to address a specific design or construction problem, and if not modified, the standard will impose an undue hardship on the applicant with little or no material benefit to the public.

1.5. TECHNICAL GUIDANCE

The review shall ensure all criteria for approval are adequately considered and that justification for the deviation is properly documented.

1.6. LIMITS OF APPROVAL

Whether a request for deviation is approved as proposed or with conditions, the approval is for project-specific use and shall not constitute a precedent or general deviation from these Standards.

1.7. REVIEW FEES

A Deviation Review Fee shall be paid in full at the time of submission of a request for deviation. The fee for Deviation Review shall be as determined by resolution of the BoCC.
