- 7) The annual withdrawal of ground water from this well, in combination with the other wells operating pursuant to case no. 07CW0129, may vary from year to year up to a maximum of 110 acre-feet, and is subject to limitations due to the availability of augmentation water to replace projected lagged depletions as described in the decree.
