Thank you again for the conversation and emails.

In response to your question, I can tell you that the organizational chart I sent you is current. Our staff is adding it to the County's website this week.

Regarding your meeting request, I understand you would like to raise procedural concerns about the Planning Commission. The Red Rocks Acres item is actually a quasi-judicial matter noticed for a hearing before the Board of County Commissioners on September 14, 2021. While I appreciate that your concerns are procedural in nature, I would ask that you forward them in writing. This ensures a number of things:

1. I will be able to route them appropriately so your concerns are part of the formal record before the Board next Tuesday;
2. This removes the risk of an *ex parte* communication with any Commissioner on the substance of the item;
3. As a practical matter I do not believe calendars will line up for a meeting this week anyway.

I am still happy to meet after the land use process is complete. Please let me know if you have questions. Thanks.
