Happy Friday. Hope all is well in your neck of the woods. My in-house engineering team, who is working on coordinating with Badger for potholing efforts at our Pike Solar project location, has a question

Can you ask our KM contact to ask the following question to their technical group/whoever is responsible for observing the pot-holing effort and approving the crossing agreements?

We have two crossings, labeled Loc 5 and Locs 6, 7, and 8, in the attached kmz, that collocate cable and roadway crossings. As such, the distance from the edge of the road to the edge of the furthest cable crossing is 50 ft, that's 50 linear feet along the pipe. Currently we plan to pothole in the middle of this 50ft area above the pipe to inform engineering design and the crossing agreement. Will one pothole be sufficient for these purposes? We anticipate that multiple pot-holes may be necessary during construction at these locations.

If you wouldn't mind letting me know your thoughts, it would be appreciated. Have a great rest of the day.

Hi Julia,

Sorry it took me some time to respond. As you can imagine with this extremely cold weather it has put all my focus on Operations issues.

I am still looking into temperatures and I was asked over and over again why juwi will need that information. Is there a specific reason for this?

The reason we need the pipe temperature is to evaluate cable ampacity. The cables dissipate heat energy into the soil, and if there is already heat being put into the soil by the pipeline, then the crossing will be hotter than it would be without the pipeline. The pipeline is a heat source, at least if it is operating at a temperature higher than 25°C. If the cables are designed to run right at the limit without the pipeline heat source, then the cable rating would be exceeded when crossing the pipeline and would fail. If we model our cable ampacity with the inclusion of the pipeline heat source, then we can correctly design the crossing such that the cable temperature ratings are not exceeded

In addition, please remind me on what you mean the boring depths? Are you ready to get the hydrovac scheduled?

We want the alignment of the pipelines within our site in order to design our borings beneath the line. An alignment should have the pipe inverts which tell us how deep the pipe is. Any alignment they can share that has pipe inverts, elevation, or depth below grade will help us design our crossings for this project.

Hi Julia,

I created a preliminary map of each crossing location. There are a couple of issues if you would please take a look.

1. Encroachment No 2 is north of encroachment 1 and does not match the map you sent. Will you please verify the lat/longs are correct?

Encroachment No 2 is actually NOT north of number one. They checked the lat/long and were correct via GoogleEarth. The points created by plugging in lat/long are attached. Let me know if this does not work and we can regroup from here.

1. Encroachment No 3 will not pull up on the map whatsoever. I input the data several times just to be sure it wasn't an error in my data entry. Will you please verify the lat/longs are correct?

Confirmed that the lat/long are correct in GoogleEarth. See if the attached will help identify?

1. Encroachment No 6. I just want to make sure that you are aware that there are 3 separate pipelines at this location with various sizes (16", 20", 12.75"). If you bore/cross at this location you will have to cross all 3 pipelines and maintain a constant elevation and cannot angle the bore up into any part of the CIG easement. The same would apply for the road crossing.

Yes, we are aware of the multiple pipelines in this area and will be sure to remain at depth for the entirety of the easement when boring. This has come up in our conversations before and we are completely prepared to see similar language in our crossing agreements and accommodate this into our boring designs.

Also, she wanted me to mention that lat/long are in decimal degrees and not degree minuets. If it helps, they were measured in LL-HPGN, which is the NAD 83 High Accuracy Reference Network (HARN) Datum of the US.

Please let me know if the attached still isn't properly reflecting and I might loop in our engineer so I don't make things more complicated or misconvey.

Thanks so much for your super quick response. Well, that was convenient, lol. Now that I think of it, you might be the individual who worked with Eli Johnson on our last El Paso County solar project, Palmer Solar, and how we originally reached out, so this makes perfect sense.

As I am sure you are somewhat familiar, juwi is a utility scale solar developer and EPC contractor based in Boulder, CO that is developing a set of 5 solar projects for Tri-State Generation and Transmission with commissioning dates near the end of 2023. We have another project in El Paso County called Pike Solar, which will be a 175 MWac solar energy generation facility with a centralized AC-coupled 25MW/100MWh battery energy storage system and spans roughly 1,162 acres.

Our reasoning for reaching out again for our Pike project is because juwi needs to span the pipeline easement in various locations in support this project, similarly to the fashion in which we did with Palmer Solar. I've attached a .kmz of the site location which shows all areas in which we would ideally like the opportunity to span this pipeline. [Please note that the widths outlined are currently just rough estimates.] I've also attached a copy of the prior Pipeline Crossing Agreement executed between KM and Palmer Solar LLC for reference, in the event helpful.
