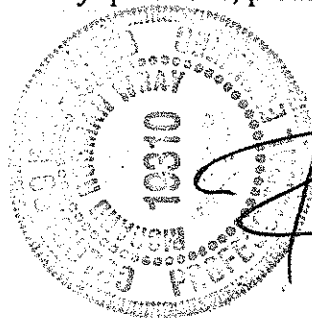

Dear Ms. Ruiz:

As requested by the County, a Final Drainage Letter has been prepared in support of the standalone grading request for the Widefield Commercial Center Subdivision No. 1. The Owners of the property, Glen Investments II intend to complete overlot grading of the property in anticipation of future development of the site. The site was platted in 2009 and at that time it was proposed for commercial use, specifically mini-warehouses. The location of the site is shown on attached Figure 1.

The final drainage report entitled "Preliminary Drainage Report Widefield Commercial Center Subdivision Filing No. 1 and Final Drainage Report for Lot 1 and Tract A Widefield Commercial Center Subdivision Filing No. 1" was prepared by Kiowa Engineering in 2010 and subsequently approved by the County in July 2001. This report has been reviewed by Kiowa as part of preparing the overlot grading plan for the site. Based upon this review, the proposed overlot as proposed by the Owner grading will not alter or change the findings of the approved drainage report for this Subdivision. The completion of the grading as proposed will not prevent the stormwater management facilities constructed in the future from being in conformance with the approved final drainage report for the Subdivision.

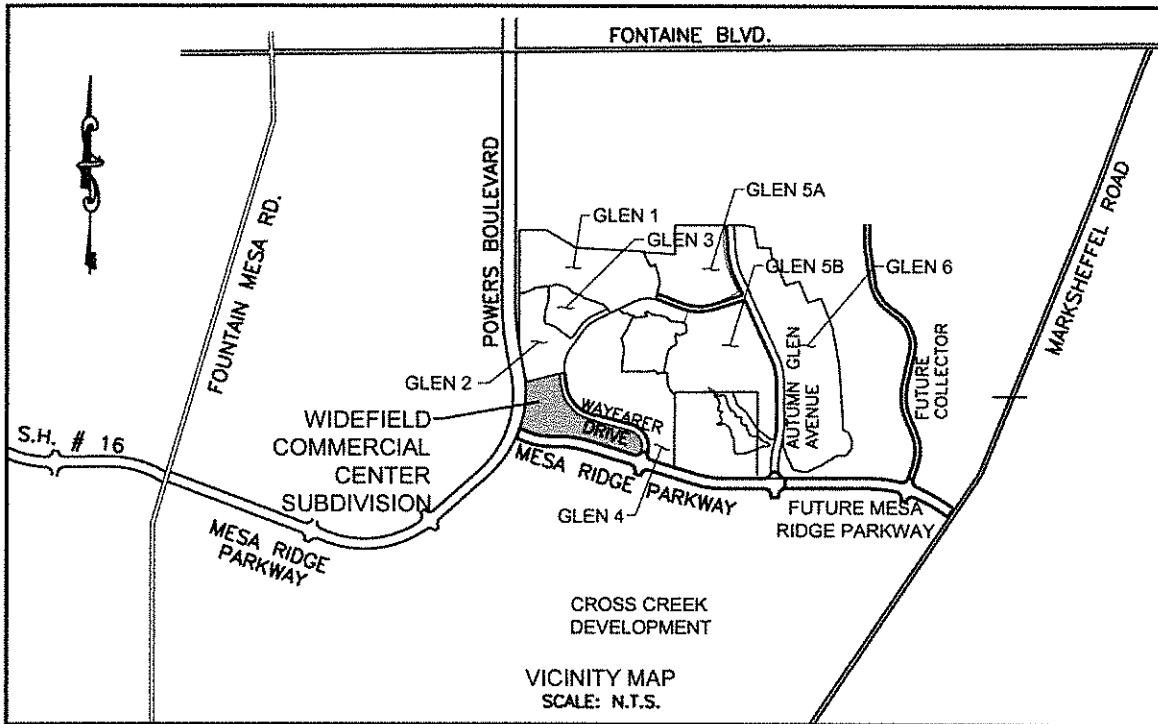
