This letter is to inform property owners adjacent to the above mentioned properties that the applicant, Savio Construction, Inc., has requested approval of administrative relief to allow a front-yard setback of 20 feet where 25 feet is required for a covered porch within the RS-5000 (Residential Suburban) zoning district. The Planning and Community Development Director may make a formal decision regarding the administrative relief request on October 10, 2017 at 4:30 P.M. At the discretion of the Planning and Community Development Director, the approval process may be elevated to the Board of Adjustment for consideration. Administrative approval by the Planning and Community Development Director is subject to the appeal provisions of the Land Development Code.


