However the latest Construction Drawings plan set removed the GEC sheets from the plan set (plot date 8/31). a. Return the GEC sheets to be a part of the Construction Drawings plan set (sheets ECGN01, EC01, EC02, ECDT01-ECDT04) and update the sheet index. Once this is complete then the plan set is ready for signatures. b. If the design engineer's intent is to provide a standalone GEC plan set then include a cover sheet with the signature blocks to the GEC plans. 3.
