**Escort Conditions**

- The OS/OW driver must give a copy of this transport permit to all pilot escort vehicle drivers required under the provisions of the permit.
- Two certified pilot cars will accompany the load at all times unless otherwise specified, one in the front and one in the rear.
- The pilot escort driver cannot be a tillerman while piloting the load, nor will the tillerman be in the pilot escort vehicle while performing tillerman operations.

**Special Restrictions**

- Destination: 10000 Squirrel Creek Rd Fountain, CO 80817
- Oversize load sign in front and rear.
- NO MOVEMENT DURING INCLEMENT WEATHER. CHECK [www.COTRIP.org](http://www.COTRIP.org) FOR ROAD INFORMATION.
- Absolutely no convoying. Maintain half (1/2) mile distance between any oversized loads.
- NO oversize movement is EVER allowed where the chain law is in effect. Overweight ONLY are allowed to chain up and proceed as conditions allow. See Rule 2 CCR 601-4 and 2 CCR 601-9.
- Travel PROHIBITED when hazardous conditions exist included SNOW, ICE, MUD, ROCKS, WINDS and REDUCED VISIBILITY.
- Must contact local municipalities (City/County) for permission to use their roads.
- Permittee is advised to run this route prior to movement and check clearances and turns due to extreme dimensions of load.
- Must carry and adhere to the route survey performed providing explicit directions on travel and maneuverability along the route.
- Load must travel in the center of the driving lane when crossing bridges and cannot exceed 40 MPH when crossing all bridges.
- NOTICE: Any emergency or additional assistance of any kind provided by CDOT, CSP or a local authority on this load will be billed to the company, including but not limited to labor, equipment and materials costs in the event the vehicle or load becomes stuck, impedes travel on any road, causes any damage to the highway or any highway structure, or in any manner impacts movement of other traffic. Company affirmatively agrees that immediate and prompt payment will be made and acknowledges that no further OSOW permits will be issued to them while any payment is pending.
- Must use pullouts to allow traffic build-up to pass.
- When CDOT issues this permit, it does not assume any liability in regard to the condition of roads or capacity of culverts or bridges. It is the permittee's responsibility to make necessary inspections of the road or bridge before proceeding. In addition, CDOT field officials have the authority to suspend this permit at any time.
- This permit is not authorization to cross load posted structures.

On over height permits: It is your responsibility to check all low overhead structures.

Must display a sign on the vehicle stating: 'CAUTION: This vehicle may slow to 10 MPH to cross bridges.'

Must not exceed 10 MPH when crossing bridge ZI-24-B at 1.7 MI NE OF LINCOLN-CHYN.

**PERMIT SHALL BE SIGNED AND CARRIED IN TOWING VEHICLE DURING MOVEMENT.**

The undersigned agrees:

1. To take every precaution to protect the highway and traffic from damage or injury, using certified pilot cars or flagpersons to warn the traveling public on all blind curves, both horizontal and vertical:
2. In case of an overwidth load, the same is to be placed on the vehicles with the overhang as far to the right as possible, and in any event the materials shall be loaded so as to present the minimum hazard to the public.
3. To be financially responsible and to make prompt payment for any damage caused to the traffic, to traffic lights, overhead signs, wires, cables and other installations or to the highway or bridges by the transportation of this load. C.R.S. 42-4-512.
4. That the operator of the vehicle(s) is duly licensed according to statute.
5. To operate the vehicle or vehicles at all times in accordance with any and all provisions of the law, except as exempted herein, with regard to motor vehicles and the operation thereof.
6. That he/she understands and accepts all provisions and requirements of this permit.
7. To indemnify and hold harmless the State of Colorado, the State Department of Transportation, its officers and employees, appointed officials and all members of the State Transportation Commission from all suits, actions or claims of any character whatsoever brought because of injuries or damage received by any person, persons or property arising from the issuance or use of this permit.
