3. 11555 Goodson Road, Colorado Springs, CO 80908 is located in the SOUTHWEST ONE-QUARTER (SW1/4) OF THE SOUTHWEST ONE-QUARTER (SW1/4) OF SECTION 13, TOWNSHIP 12 SOUTH, RANGE 65 WEST OF THE 6TH PRINCIPAL MERIDIAN, COUNTY OF EL PASO, STATE OF COLORADO. The property is assigned El Paso County Tax Schedule No. 5213000004 and is currently zoned RR-5. The property size and area of proposed special use is 40 acres.
4. My wife Megan Miller and I request Special Use approval to utilize the existing equine structures and improvements on our property to board not more than 30 total horses (inclusive of those owned by us) and to allow recreational equine facility use for private clients. We have been living on and rehabilitating the property for six years, and personally operate and maintain our residence and business. The proposed equine boarding operations will use only existent structures, utilities, access, and signage. All structures, stalls and lighting are in excess of 100 feet from

property lines. All manure will be removed and spread (broadcast) on the pastures or hauled offsite with regularity.

Fawnwood Ranch was originally built in 1975-76 by Richard Stewart as a personal residence and AQHA horse farm. The main equine barn is considered a local landmark by some, and contains nine stalls with corral turnouts, an indoor arena, and heated meeting, galley, tack, and restroom facilities. The residence, three loafing stalls, extensive pipe fencing, and a well house were also constructed at this time.

My family purchased the property in the 1980s and has since used it as a seasonal family residence. In 2010, an addition was constructed, and extensive remodeling and rehabilitation of both the residence and equine facilities began and is on-going. In 2015, a hay and equipment barn was added. In 2017, upon dissolution of the controlling family partnership, I took full ownership of this parcel.

The property possesses deeded and determined water rights and contains two permitted wells sufficient and appropriate for proposed use.

With the exception of a small, portable equine loafing shed to be acquired at a later date, no other structures or improvements are currently needed or proposed for Fawnwood Ranch operations.

We suspect that you live in the Black Forest because you value the rural setting, privacy, and beauty of this area and we hope you will agree that this endeavor is congruous with the existing neighborhood. We are proud of the work that we have done (and continue to do) here and want to preserve the rural charm of Fawnwood and our corner of the Black Forest. We are more than happy to show you around or answer any questions or concerns you might have regarding the issuance of the Special Use Permit or our business plan.


