

LEGAL DESCRIPTION - Latigo temporary turnaround easement

A TRACT OF LAND BEING A PART OF THE SOUTHWEST QUARTER OF SECTION 16, TOWNSHIP 12 SOUTH, RANGE 64 WEST OF THE SIXTH PRINCIPAL MERIDIAN, COUNTY OF EL PASO, STATE OF COLORADO, DESCRIBED AS FOLLOWS:

"COMMENCING" AT THE SOUTHWEST CORNER OF SAID SECTION 16 AND CONSIDERING THE SOUTH LINE OF SAID SECTION 16 TO BEAR SOUTH 89°26'11" EAST, WITH ALL BEARINGS CONTAINED HEREIN RELATIVE THERETO; THENCE NORTH 38°43'42" EAST, A DISTANCE OF 3268.47 FEET TO A NON-TANGENT POINT OF CURVE ON THE NORTHEASTERLY LINE OF THAT PROPOSED LOT 43 OF THE FUTURE LATIGO TRAILS FILING 10 SUBDIVISION, EL PASO COUNTY PROJECT NUMBER SF-24-21, WHENCE THE RADIAL LINE BEARS SOUTH 89°20'02" WEST, SAID POINT BEING THE "POINT OF BEGINNING"; THENCE NORTHWESTERLY 18.10 FEET ALONG THE ARC OF A CURVE TO THE LEFT HAVING A CENTRAL ANGLE OF 34°33'32", A RADIUS OF 30.00 FEET AND A CHORD WHICH BEARS NORTH 17°56'44" WEST, A DISTANCE OF 17.82 FEET TO A POINT OF REVERSE CURVE; THENCE 289.42 FEET ALONG THE ARC OF A CURVE TO THE RIGHT, HAVING A CENTRAL ANGLE OF 276°22'44", A RADIUS OF 60.00 FEET AND CHORD WHICH BEARS SOUTH 77°02'08" EAST, A DISTANCE OF 80.00 FEET TO A POINT OF REVERSE CURVE; THENCE 18.07 FEET ALONG THE ARC OF A CURVE TO THE LEFT, HAVING A CENTRAL ANGLE OF 34°30'43", A RADIUS OF 30.00 FEET AND CHORD WHICH BEARS SOUTH 43°53'52" WEST, A DISTANCE OF 17.80 FEET TO A NON-TANGENT POINT; THENCE NORTH 77°03'29" WEST, A DISTANCE OF 61.70 FEET TO THE "POINT OF BEGINNING".

CONTAINING 11,522 SQUARE FEET OR 0.265 ACRES, MORE OR LESS.
