### Description of Request –

Rice Ranch LLC, is requesting to change our parcel uses from M Zone and A-5 Agricultural to I-3 Industrial Zone. This request is being made to bring Rice Ranch LLC in compliance with its current uses on the property. A rezone to the I-3 (Heavy Industrial Zone) allow for the outside storage and heavy equipment storage uses that are already onsite. This is unlikely to develop as residential or agricultural due to it being located in a high industrial area and also is within a floodplain. It is not intended at this time to change the boundaries in those wetland areas, only to provide a safe environment and adjustments as necessary to facilitate and maintain these area.
