A 6,000 S.F. metal building is being proposed on the property for worship, administrative, and training use. In addition, a gazebo will be placed at the northwest corner of the property. Currently, a 400 SF mini house is the parsonage. That will be replaced in the future by a full size single-family residential structure. The structures will be connected to a single septic system for waste water. The lot will be entered from an existing public road, Lindbergh Road. These utilities exist to service the site: Black Hills Energy for gas and Mountain View Electric.
