Our response comments to follow are in ***Bold Italics*** following each original review comment.

Grading and Erosion Control Plan / SWMP (School Site)

1. Provide P.E. signature and stamp on all sheets with the final submittal. ***Included***
2. Provide a boundary/limit of disturbance for the disturbed area under the school district's responsibility and label as such. ***Limits of disturbance now shown & labeled***
3. See electronic GEC plan redlines for additional comments and questions. ***Comments have been addressed.***
4. Provide a separate SWMP and ESQCP for the school site if this work will be under the school district's authority and contracting. If the school district will be responsible for providing fill or stockpiling in a specific area (such as opposite Lamprey from the school parcel), provide those sheets showing any additional phasing as well. If Lorson Ranch will maintain responsibility for the fill areas outside of the school site provide a note stating this. ***SWMP & ESQCP have been provided. Note has been added to plan stating that the school district is responsible for the area within the limits of disturbance and Lorson Ranch is responsible for anything outside of those limits after the initial export grading.***
5. Ensure that all SWMP checklist items (attached) are provided. Notation/explanation must be provided for items that are not applicable. ***Checklist provided.***

1. Provide P.E. signature and stamp and owner's signature with the final submittal. **Included**
2. Include all necessary grading and erosion control items in the FAE (see redlines). **Updated FAE has been included.**
