VARIANCE OF USE (Approved)

Commissioner Lucia-Treese moved that the following Resolution be adopted:

OF THE COUNTY OF EL PASO STATE OF COLORADO

RESOLUTION NO. VA-19-006 Quarter/Three-Quarter Lazy J Second Dwelling

WHEREAS, trustees of Quarter Circle Lazy J, did file an application with the Planning and Community Development Department of El Paso County for approval of a variance of use within the RR-5 (Residential Rural) zoning district to permit second dwelling where such use is not permitted; and

WHEREAS, a public hearing was held by this Commission on October 15, 2019; and

WHEREAS, based on the evidence, testimony, exhibits, presentation and comments of the El Paso County Planning and Community Development Department and other County representatives, comments of public officials and agencies, comments from all interested persons, comments by the general public, and comments by the Planning Commission Members during the hearing, this Commission finds as follows:

- 1. That the application was properly submitted for consideration by the Planning Commission.
- 2. That proper posting, publication and public notice were provided as required by law for the hearing before the Planning Commission.
- 3. That the hearing before the Planning Commission was extensive and complete, that all pertinent facts, matters and issues were submitted and that all interested persons and the general public were heard at that hearing.
- 4. That all exhibits were received into evidence.
- 5. That the proposed land use does not permit the use of any area containing a commercial mineral deposit in a manner which would interfere with the present or future extraction of such deposit by an extractor.
- 6. That the proposed variance of use conforms to Chapter 5, Use and Dimensional Standards, Section 5.3.4, Variance of Use, of the El Paso County Zoning Resolutions.

 That for the above-stated and other reasons, the proposed variance of use is in the best interest of the health, safety, morals, convenience, order, prosperity and welfare of the citizens of El Paso County, and

WHEREAS, pursuant to Section 5.3.4 of the <u>El Paso County Land Development Code</u>, as amended, in approving this variance of use, the Planning Commission considered one or more of the following criteria:

- The strict application of any of the provisions of the <u>Land Development Code</u> would result in peculiar and exceptional practical difficulties or undue hardship on either the owner or the contract purchaser of the property;
- The proposed use is compatible with the surrounding area, harmonious with the character of the neighborhood, not detrimental to the surrounding area, not detrimental to the future development of the area, and not detrimental to the health, safety, or welfare of the inhabitants of the area and the County;
- The proposed use will be able to meet air, water, odor or noise standards established by County, State or Federal regulations during construction and upon completion of the project;
- The proposed use will comply with all applicable requirements of the <u>Land Development</u> <u>Code</u> and all applicable County, State and Federal regulations except those portions varied by this action;
- 5. The proposed use will not adversely affect wildlife or wetlands;
- 6. The applicant has addressed all off-site impacts;
- The site plan for the proposed variance of use will provide for adequate parking, traffic circulation, open space, fencing, screening, and landscaping; and/or
- Sewer, water, storm water drainage, fire protection, police protection, and roads will be available and adequate to serve the needs of the proposed variance of use as designed and proposed.

NOW, THEREFORE, BE IT RESOLVED that the application of trustees of Quarter Circle Lazy J Trusts for a variance of use within the RR-5 (Residential Rural) zoning district to permit second dwelling where such is not a permitted use for the following described unincorporated area of El Paso County be approved:

AND BE IT FURTHER RESOLVED that the Planning Commission recommends the following condition and notation(s) shall be placed upon this recommendation:

CONDITION

Any subsequent addition or modification to the additional dwelling unit beyond that
described in the applicants' letter of intent and as shown on the site plan shall be subject to
administrative review, and if it is the opinion of the Planning and Community Development
Department Director that it constitutes a substantial change, then such addition or
modification shall be subject to review and approval by the Board of County
Commissioners.

NOTATIONS

- 1. Variance of use approval includes conditions of approval and the accompanying site plan and elevation drawings. No substantial expansion, enlargement, intensification or modification shall be allowed except upon reevaluation and public hearing as specified in the El Paso County Land Development Code.
- 2. The Board of County Commissioners may consider revocation and/or suspension if zoning regulations and/or variance of use conditions/standards are being violated, preceded by notice and public hearing.
- 3. If the variance of use is discontinued or abandoned for two (2) years or longer, the variance of use shall be deemed abandoned and of no further force and effect.

AND BE IT FURTHER RESOLVED that this Resolution and recommendations be forwarded to the El Paso County Board of County Commissioners for its consideration.
