PROJECT DESCRIPTION
WALDEN PRESERVE 2, FILING 5

Walden Preserve 2, Filing No. 5 consists of 91.85 acres facilitating; 50 single family residential lots at a minimum of 1.0 ac each, 32.10 ac of open space and 6.72 ac of road right-of-way dedication. All roadways will be designed and constructed to El Paso County standards and are intended to be dedicated to El Paso County for ownership and maintenance.

Walden Preserve 2, Filing No. 5 is zoned PUD Planned Unit Development with County approved PUD Development Plans and Preliminary Plans on file with Planning & Community Development. Completing the subdivision, Filing No. 5 is the fifth and last Walden Preserve 2 Filing.
