NOTICE TO PROPERTY OWNERS

Dear Property Owner:

This letter is being sent to you because M.V.E., Inc., on behalf of Security Fire Department and Glen Investment Group No. II, LLC, is proposing a land use project in El Paso County on a property located between Mesa Ridge Parkway on the north and Wayfarer Drive on the south approximately 1000 feet west of the intersection of the two streets. The site has no assigned address but it is a portion of the 18.5-acre parcel with Tax ID No. 5528200005. A Vicinity Map is included for reference. The project is a "Approval of Location" to allow construction of a new fire station on 1.211± acres in the CS CAD-O zone (Commercial Service with Commercial Airport District Overlay). The subject property is currently vacant. The proposal is part of the land use approval process with includes the Subdivision Exemption and Site Development Plan requests of which you were previously notified. The site is proposed to contain the new fire station, access drives, parking, landscaping and stormwater detention/water quality treatment. The improvements on the site will be consistent with the existing CS CAD-O zoning. Access to the fire station will be from Wayfarer Drive. This information is being provided to you as part of the land use application submittal process with the County. Please direct any questions on the proposal to the referenced contact below.

The request is for "Approval of Location" for a new Security Fire Protection District fire station to be constructed on the property.

Prior to any public hearing on this proposal a notification of the time and place of public hearing will be sent to the adjacent property owners by the El Paso County Development Services Department. At that time you will be given the El Paso County contact information, the file number and an opportunity to respond either for, against or expressing no opinion in writing or in person at the public hearing for this proposal. 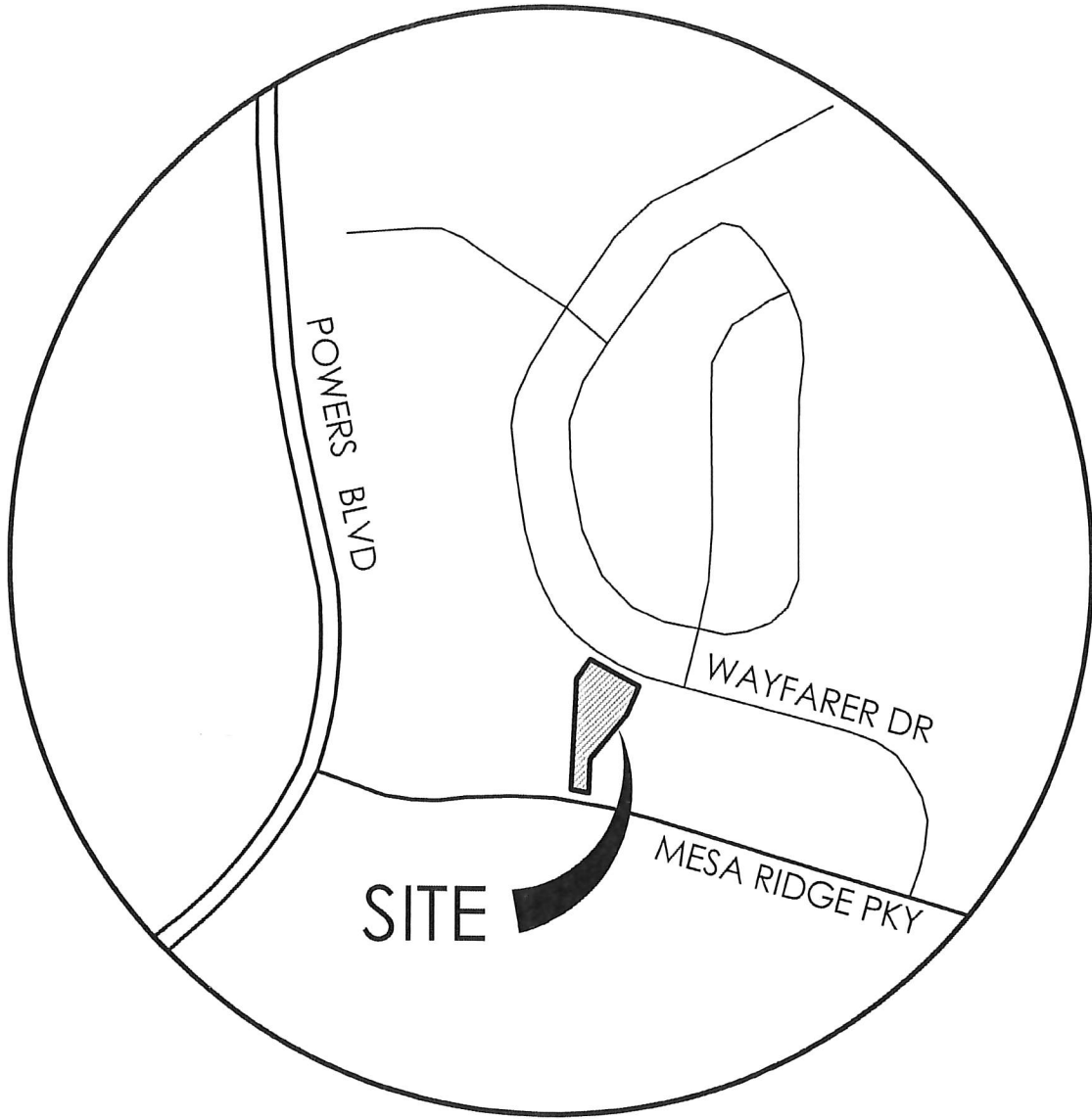
