My husband and I have been residents of the Tri Lakes area in El Paso County since 1981, and are very disturbed to hear of the drug and alcohol rehabilitation facility proposed in Woodmoor. We already have two in the Tri Lakes area and feel it will be very detrimental to the Tri Lakes Area. Monument residents recently fought a rehab clinic when it was proposed there, and this is a similar situation. The proposed site is walking distance to an elementary school, a middle school, library, retail outlets, and more than 100 housing units.

We feel that 150 patients would be impossible to supervise as the existing building has outdoor access for all units, and the surrounding area will be jeopardized, and real estate values will certainly decline. Dear Commissioners

I hope this message finds you well. As a resident of unincorporated El Paso County, I recently learned of this project, via social media, for yet another attempt to add a drug rehabilitation facility in the Tri-Lakes area in Monument.

As I am sure many of you are aware, a recent effort to put in a methadone clinic in downtown Monument was shot down by community activism. Citizens rallied and were able to defeat the attempt.

Yet, here we are again. At this point, I simply cannot understand or fathom why these companies continue to try and move into such a small community. Do we not have enough drug treatment businesses, one of which is in a residential area, in the community? Do we really need to add yet another one? In fact, the facility in Palmer Lake is expanding! Why do we have to bring the issues that come with these facilities to such a small community? We moved our family to Monument to escape these kinds of things.....now we find ourselves fighting them even more!

Needless to say, the proposed site is right in the middle of Lewis Palmer middle school and Lewis Palmer elementary school, which of course never gets taken into consideration by these companies.
