To whom it may concern,

The intent of this letter is to notify that I have read and verify that we comply with the general standards for Residential Home Occupation on section #4 of the Land Development Code. I the owner of the property who resides in it will only be the person providing the barbershop service. I will not have any other employee or person providing service. The business will have available 3 parking spots which will be inside the property perimeter. I will only be accepting customers by appointment which will count with no more than 2 customers at a time. The building is 20x10, which is approximately 200 sqft. And it's less than 25% of the home parcel. It has his own entrance, and the building is in the backyard of my home property which it doesn't interfere with the main property entrance or any other property. Please include answers on the following:

**(d)Signage and Advertising.** There shall be no advertising of the home occupation visible outside the dwelling except in accordance with the signage provisions in Chapter 6.

**Answer:** There won't be any signage or advertising of the home occupation visible outside the dwelling except in accordance with the signage provision in Chapter 6. We will only have customary exterior residential lighting which will be inside of the property.

**(e)Outside Storage Prohibited.** There shall be no outside storage or display on the premises of material, tools or equipment used as part of the home occupation or any products manufactured as part of the home occupation.

**Answer:** We don't have any outside storage or display on the premises of any kind of materials, etc. as part of the home occupation.

**(f)Sales Limited.** No sale of goods, supplies, or other inventory shall be allowed unless the sales are clearly incidental and related to providing a

service (e.g., sale of hair care products at a beauty shop; occasional sale of a firearm by a gunsmith; incidental retail sales where the home occupation is a mail order, internet, or delivery business, brokers of firearms where inventory is not maintained on site except for specific transactions) or unless the items are produced, constructed or assembled on the premises or are clearly incidental and related to the sale of the homemade items. Nothing in this Section shall limit the ability of the home occupation to sell products mail order via the internet or by telephone.

The home occupations operator shall be required to obtain and maintain all applicable licenses and pay applicable sales tax.

**Answer:** The only service that will be provided is haircuts. There won't be any goods, supplies or other inventory sales in the home occupancy or property.

**(g)Limit on Visitation by Clients.** The occupation will ordinarily not bring more than 3 clients or customers to the lot or parcel at any one time.

**Answer:** Their will only be a max of 3 clients or customer at any one time.

**(j)Conducted In Accordance with Laws.** The occupation is conducted in compliance with all applicable building, fire, health, and environmental laws, codes, and regulations.

**Answer:** Yes, the occupation is conducted in compliance with all applicable building, fire, health and environmental laws, codes, and regulation.

**(k)No Visual Impacts.** No activity associated with a home occupation shall be allowed which results in detrimental visual impacts to the surrounding neighborhood.

**Answer:** There won't be any activity associated with a home occupation which result in detrimental visual impacts to the surrounding neighborhood.

**(l)More than One Home Occupation Allowed.** More than one home occupation may be conducted on any property provided that aggregate impacts are limited to those allowed by this Code.

**Answer:** Their will only be one home occupation which this code allows.

**(m)Deliveries Limited.** Deliveries other than standard parcel services are prohibited when associated with a home occupation.

**Answer:** Their will only be standard parcel deliveries services associated with a home occupation.
