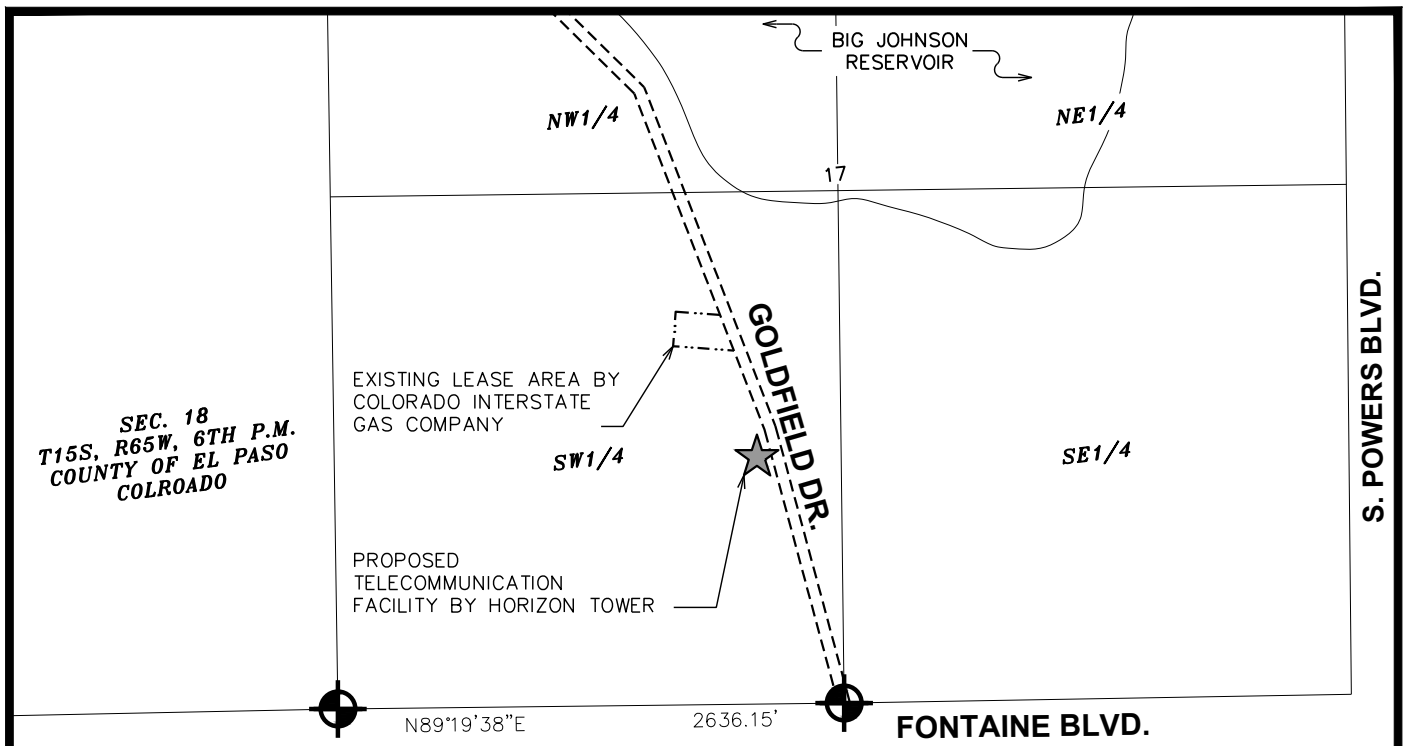

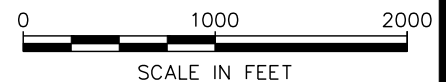

Size and Zoning: Approximately 937 acres zoned A-5 CAD-O
4. Request and justification: Horizon Tower is proposing to construct a 70' wireless telecommunications facility **designed as a stealth water tower**. This facility was designed to accommodate multiple wireless carriers, which limits tower proliferation in the area. The location was chosen to achieve maximum coverage with the least visual impact to adjacent properties while providing a location to remedy a significant gap in coverage. **Please see the attached photo-simulations** showing the water tank from various angles.

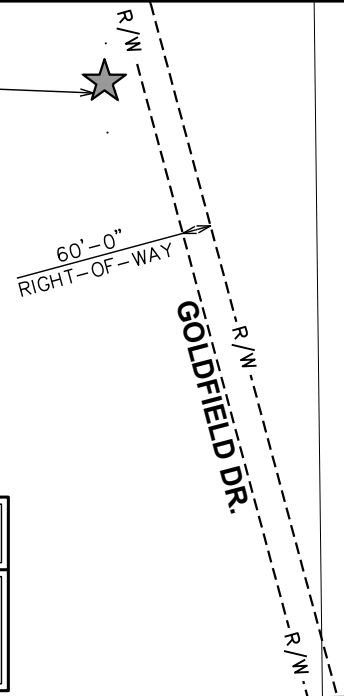

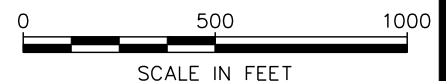

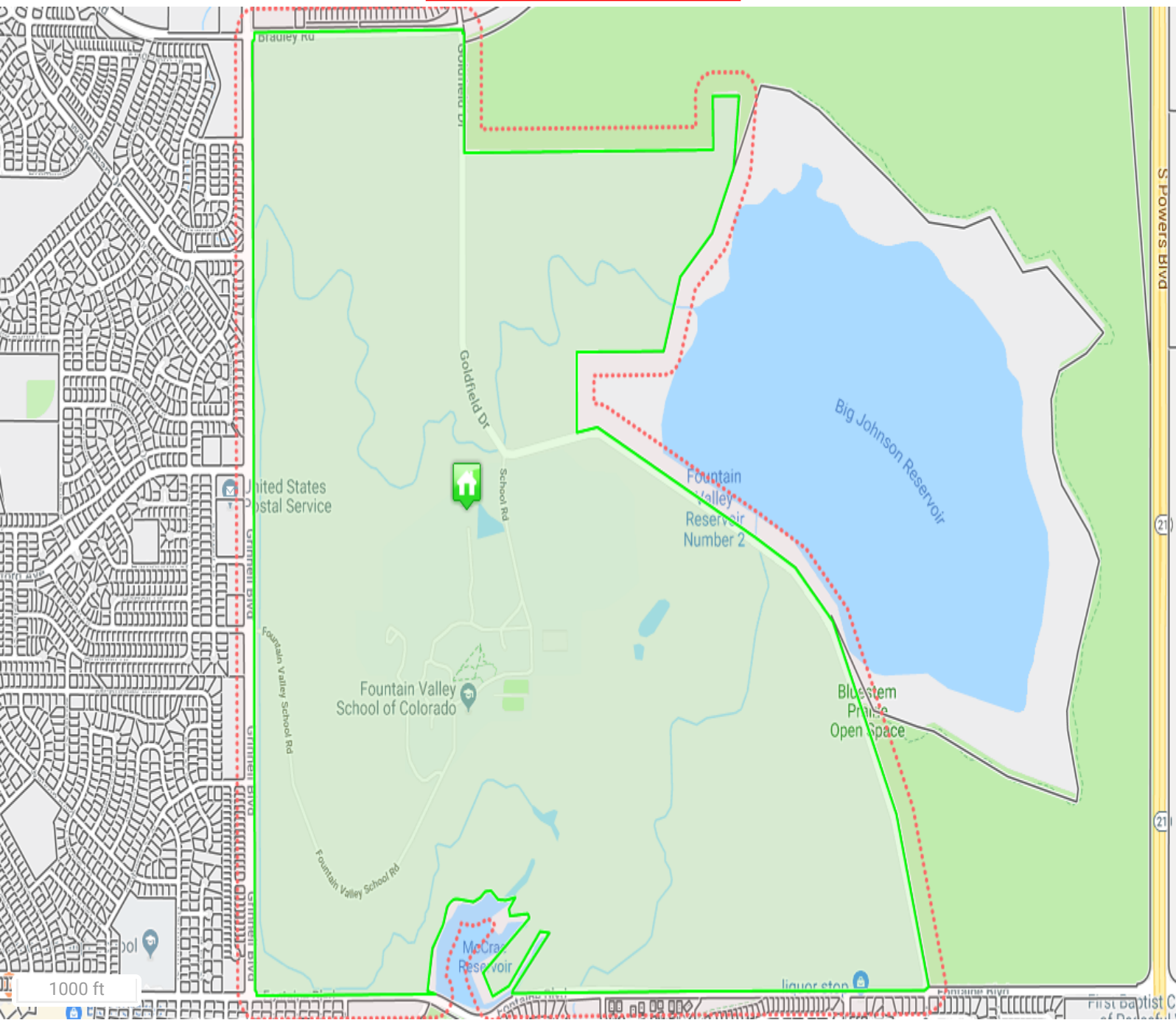
