Request by Stantec on behalf of Mule Deer Investments, LLC for approval of the Gardens at North Carefree final plat. The plat creates 71 single-family lots on 11.56 acres. The site is zoned PUD (Planned Unit Development) and is located southeast of the intersection of North Carefree Circle and Akers Drive.

**Review Note:** A development plan and rezone for the Mule Deer Villas (a 125-unit townhome development) was reviewed and approved by the Commission in February 2018. The development of the Gardens at North Carefree (71 single-family lots) amends the development of the Mule Deer Villas.


