We believe Monument Glamping will add to the greater Master Plan of the county, compliment our neighborhood, respect the surrounding habitat, and comply with all County rules, regulations and ordinances.

Since 2019 we have had a total of six glamping units on the property, and we wish to maintain the six with an added capacity of no more than eight units. Property upgrades include a new driveway, fencing, landscaping, bushes and trees, and more to accentuate the glamping experience while minimizing the impact to our quaint and pleasant rural-residential neighborhood.
