It is the determination and finding of the Planning and Community Development Department (PCD) Director that the application meets the review criteria for approval of a special use included in Section 5.3.2 of the El Paso County Land Development Code (2019).

This approval is subject to the following conditions and notations:

## **CONDITIONS OF APPROVAL**

1. Approval is limited to the major kennel for 14 dogs, as discussed and depicted in the applicant's letter of intent and site plan drawings.

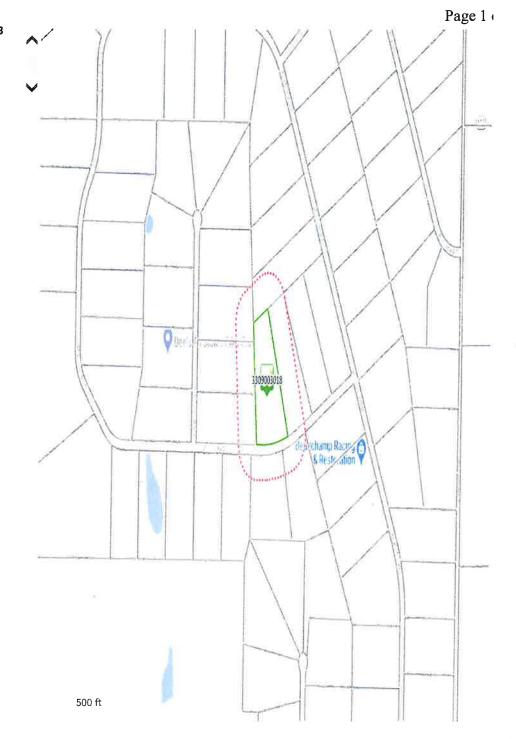
## **NOTATIONS**

- 1. The special use approval includes approval by the PDC Director to reduce the 200 foot kennel setback requirement to 130 feet pursuant to those authorities granted within the Use Specific Standards of Chapter 5 of the <a href="Land Development Code">Land Development Code</a>. The PCD Director hereby approves the reduced setback requirement based upon the specific justification provided in the applicant's special use application.
- 2. Special use approval includes conditions of approval and the accompanying site plan and elevation drawings. No substantial expansion, enlargement, intensification or modification shall be allowed except upon reevaluation and public hearing as specified in the El Paso County Land Development Code.
- 3. The Board of County Commissioners may consider revocation and/or suspension if zoning regulations and/or special use conditions/standards are being violated, preceded by notice and public hearing.
