Please add my objection to the proposed Buc-ees at the SW intersection of County Line Road and I-25. Like many of my neighbors who attended the informational meeting on December 3<sup>rd</sup> at Palmer Lake Elementary School, I think this is a horrible idea. I live in Wakonda Hills off of Beacon Lite, and do not see this as serving my neighborhood.

The land in question does not have sufficient water rights on its own. If they somehow gain access to the large amount of water needed to support this operation, it will have negative consequences for those of us on wells in the

surrounding area. Water in our aquifer is not refilling as fast as it is being used even without large commercial entities (from reports I have read). How long until my well runs dry at its current depth?

The proposed flagpole annexation into Palmer Lake is extremely discouraging to those of us who will be directly affected by the light pollution, the traffic, the noise, the potential crime, and the clear cutting of all those beautiful trees.

I understand the lure of the tax revenue for Palmer Lake, but they aren't going to be the people directly affected by this huge monstrosity! That was even stated as a quote in one of the newspapers.

Many others have mentioned the Monument Hill weather patterns, which are readily acknowledged and recognized by locals. I STILL have snow in my driveway and yard from the last snowfall we had and that was over a week ago.

Buc-ees will potentially be responsible for an increase in traffic accidents as people attempt to get off and on the freeway. And what about Palmer Ridge students trying to get from the west over to the school? They are already less experienced at driving. Now they'll compete with travelers for the road.
