- 5. <u>Waiver requests and justification</u>. None at this time.

6. <u>Discussion</u>. A description of airport master plans and the NPIAS (National Plan of Integrated Airport Systems) is provided in the enclosed attachments. While review and approval of an "Airport Master Plan" is recognition of a plan for future growth, it should be noted that airport future plans change as requirements change. This is the fourth Master Plan for the Meadow Lake Airport (KFLY) since it was designated by the FAA as a reliever airport in 1989. The specifics of the "future" runway complex described in each Plan has changed with each update based on FAA and local requirements.

Attached to this cover letter is an extensive list of references and enclosures. Due to the unique nature of this application, we were requested to submit a "tutorial" for operating and planning for this "Regional GA Airport". To emphasize and validate information stated, direct excerpts from published references are provided. Where appropriate, excerpts from the Meadow Lake Airport Master Plan Technical Report (2018) [ref (b)] are used. Reference to "figures" and "tables" made in these excerpts are to tables and figures that may be found in the Master Plan and are not routinely repeated in this application document.

Airport Master Plans (AMPs) are living documents and as stated above, are reviewed and updated periodically due to changing conditions and FAA requirements. The FAA Airport Sponsor Assurances require that Airport Layout Plans (ALPs) be kept current. The **2020 Colorado Aviation System Plan** – Technical Report [ref (k)] states:

"Master plans are designed and developed to:"

- Provide a graphic representation of the existing airport features, future airport development, and anticipated land use
- Establish a realistic schedule for implementation of the proposed development
- Identify a realistic financial plan to support the proposed development
- Validate the plan technically and procedurally through an investigation of concepts and alternatives on technical, economic, and environmental grounds
- Prepare and present a plan to the public that adequately addressees all relevant issues and satisfies local, state, and federal regulations

• Establish a framework for a continuous planning process

The FAA approves specific components of an MP as opposed to the entire document. These components consist of the forecast of aviation demand, selection of critical aircraft, and the ALP. It is from these elements that the FAA determines eligibility of Airport Improvement Program (AIP) funding for the proposed to the entire how can you require development referenced in the MP and shown on the ALP."

With 1041 Permit approval, MLAA will ensure coordination of all future updates with modify El Paso County. In conformance with CDOT's Master Plan benchmark, another update to the Meadow Lake Airport Master Plan/ALP is listed in the "Long Term" section of the is up to Capital Improvement Plan (CIP) [Enclosure 12c]. As the need to expand the airport becomes apparent, actual construction plans will address specific County questions and concerns <u>at that time</u>. Until then, we can only provide best estimates and concepts that may apply under evolving state and federal guidelines.


