- Remove and replace marked stone on ADA ramp at Rolling Peaks Dr. and Lambert Dr. intersection (east side).
- Remove and replace marked stone on ADA ramp at Bridge Way and Rolling Peaks Dr. (southeast side).
- Asphalt patch for trip hazard at Bridge Way and Rolling Peaks Dr. intersection.
- Remove and replace marked sidewalk stones x2 at the mid block crossing at 10498 Summer Ridge Dr.
- Remove and replace curb and gutter at Valley Peak Dr and Rolling Peaks Dr. intersection (northeast side x1, southeast side x1).
- Patch marked sidewalk stone x2 at the midblock crossing between Valley Peak Dr. and Crooked Hill Dr.
- Grind asphalt patch on Rolling Peaks Dr.
- Remove and replace marked stone on ADA ramp at Rolling Peaks Dr. and Crooked Hill Dr. intersection (southeast side).
- Remove and replace marked curb and gutter x3 at Rolling Peaks Dr. and Crooked Hill Dr. intersection (southeast side).
- Repair wings as necessary on ADA ramp at Rolling Peaks Dr. and Crooked Hill Dr. intersection x2 (northwest side).
- Remove and replace truncated domes x1 on Rolling Peaks Dr. and Crooked Hills Dr. intersection (northwest side).

- Repair ADA stone x1 as necessary to eliminate trip hazard caused by truncated dome at Rolling Peaks Dr. and Crooked Hills Dr. intersection (southwest side).
- Remove and replace marked curb and gutter x1 at the ADA ramp at Rolling Peaks Dr. and Parkland Dr. intersection (southeast side).
- Remove and replace marked curb and gutter x2 at the ADA ramp at Rolling Peaks Dr. and Parkland Dr. intersection (southwest side).
- Remove and replace marked sidewalk stone x1 at the ADA ramp at Cuatro Caminos Dr. and Rolling Peaks Dr. intersection (northwest side).
- Patch marked sidewalk stone x1 at the ADA ramp at Cuatro Caminos Dr. and Rolling Peaks Dr. intersection (southwest side).
- Remove and replace marked curb and gutter at Cuatro Caminos Dr. and Rolling Mesa Dr. intersection (northeast side x1, northwest side x1, southwest side x1).
- Patch ADA wing x1 at Cuatro Caminos Dr. and Rolling Mesa Dr. intersection (southwest side).
- Remove and replace marked curb and gutter x1 at the ADA ramp at Rolling Mesa Dr. and Evening Creek Dr. intersection (southeast side).
- Remove and replace ADA landing at Rolling Mesa Dr. and Evening Creek Dr. intersection (northwest side).
- Remove and replace midblock landing off Evening Creek Dr near Evening Creek Dr and Parkland Dr. intersection (west side).
- Remove and replace marked curb and gutter near the ADA ramp x2 at Parkland Dr. and Rolling Mesa Dr. intersection.

General Note- Grind all asphalt at ADA ramps as needed to remove trip hazards.
