### EXECUTIVE SUMMARY


A request by Pikes Peak Board of Cooperative Educational Services ("PPBOCES") for Approval of Location to allow for the placement of an 86.38-acre campus consisting of Administration Headquarters, secondary vocational instruction, a community water system, up to 121 single-family residences, internal streets, parking, and common areas.

The campus will be built out in six phases. The first phase consists of Construction Trades, water treatment facility, and 10 homes. The second phase will include the PPBOCES

Administration Office and 13 homes. The third phase adds Information Technology, Law Enforcement Training, Firefighting Training and 24 homes. The fourth phase incorporates Vocational Training, Sports Field/Turf Grass Management and 26 homes. The fifth phase is comprised of Medical Training, Food Services, Culinary Arts and 25 homes. The final phase completes the campus with Veterinary Sciences, Horticultural Sciences and 23 homes. Should the Planning Commission approve the location of the campus, the applicant will be required to obtain Site Development Plan approval.

#### **A. REQUEST/AUTHORIZATION**

**Request:** A request for an Approval of Location to permit a vocational school campus.

**Authorization to Sign:** There are no items requiring signature associated with this request.

#### **B. APPROVAL CRITERIA**

Section 5.3.3.J, Approval of Location, Review Standards, of the Land Development Code (as amended) states:

*The application for a public use, structure or utility is reviewed for conformity with the submittal and processing requirements included within this Code and Procedures Manual and for conformity with the adopted Master Plan.*

#### **C. BACKGROUND**

A request by the current owner of the property, PPBOCES, was submitted on June 13, 2024, to initiate the establishment of a vocational school campus. Development is proposed to consist of secondary education facilities for vocational training, campus housing, and a community water system. PPBOCES has been given approval by the Meridian Service Metropolitan District to be included in its wastewater treatment system.

#### **D. ANALYSIS**

##### **1. Land Development Code Compliance**

The request for Approval of Location is reviewed for conformity with the requirements of the Land Development Code and conformity with the County Master Plan. Staff concurs that the proposed use complies with Section 5.3.3 of the Code regarding Approval of Location and C.R.S. 30-28-110 provided the included conditions and notations are adopted.

## **2. Zoning Compliance**

Section 5.3.3.C of the El Paso County Land Development Code (as amended) describes the applicability for the Approval of Location process as follows:

*The Planning Commission is required to review and approve construction of or plans for the construction of any road, park, or other public way, ground, or space, public building or structure, or public utility, whether publicly or privately owned prior to the construction of any facility.*

The proposed development is for the establishment of a vocational school campus. Due to the use serving a public purpose, the proposed development meets the applicability for an Approval of Location as identified above. Should the Approval of Location be approved, the applicant will be required to submit and receive administrative approval of a Site Development Plan prior to initiating construction of the PPBOCES Campus which will include Administration Headquarters, secondary vocational instruction, a community water system, up to 121 single-family residences, internal streets, parking, and common areas.

## **E. MASTER PLAN COMPLIANCE**

### **1. Your El Paso County Master Plan**

The scope of the project is located in the north/central portion of El Paso County in the Large-lot Residential Placetype/Priority Development Area. The Your El Paso Master Plan (2021) discusses the need for the accommodation of growth of student population, particularly in the northern areas of the County. Specifically, Chapter 7, Page 95, of the Master Plan states:

*The County population has grown quickly and has caused a significant need for additional schools for all grade levels, particularly in the northern areas of the County. Further, the population is projected to grow in the future, which will continue to put pressure on education facility providers. Coordination is needed to support the educational system as it absorbs this growth today and in the future.*

According to data included on Page 10 of the Master Plan, El Paso County is projected to increase in population by roughly 256,000 by 2050, which represents an approximate 35% increase in population from 2019. Due to the expected rapid

population growth, goals and objectives were developed to strategically manage the effects. A relevant goal and objective are as follows:

***Goal CFI1*** – Coordinate with agencies to provide high-quality community facilities, services, and infrastructure to enhance quality of life.

***Objective CFI1-2*** - Support efforts by the school districts to develop individual long-range capacity and facilities plans based on planned growth in El Paso County in order to accommodate actual growth.

## 2. Water Master Plan Analysis

The El Paso County Water Master Plan (2018) has three main purposes; better understand present conditions of water supply and demand; identify efficiencies that can be achieved; and encourage best practices for water demand management through the comprehensive planning and development review processes. Relevant policies are as follows:

***Goal 1.1*** – Ensure an adequate water supply in terms of quantity, dependability and quality for existing and future development.

***Policy 1.1.1*** – Adequate water is a critical factor in facilitating future growth and it is incumbent upon the County to coordinate land use planning with water demand, efficiency and conservation.

***Goal 1.2*** – Integrate water and land use planning.

The Water Master Plan includes demand and supply projections for central water providers in multiple regions throughout the County. The property is located within Planning Region 3 of the Plan, which is an area anticipated to experience growth by 2040. The following information pertains to water demands and supplies in Region 3 for central water providers:

The Plan identifies the current demand for Region 3 to be 4,494 acre-feet per year (AFY) (Figure 5.1) with a current supply of 7,164 AFY (Figure 5.2). The projected demand in 2040 for Region 3 is at 6,403 AFY (Figure 5.1) with a projected supply of 7,921 AFY (Figure 5.2) in 2040. The projected demand at build-out in 2060 for Region 3 is at 8,307 AFY (Figure 5.1) with a projected supply of 8,284 AFY (Figure 5.2) in 2060.

A finding of water sufficiency is not required with an Approval of Location.

### **3. Other Master Plan Elements**

The El Paso County Wildlife Habitat Descriptors (1996) identifies the property as having a low wildlife impact potential.

The Master Plan for Mineral Extraction (1996) identifies no significant resources in the area of the subject parcels. A mineral rights certification was prepared by the applicant indicating that, upon researching the records of El Paso County, no severed mineral rights exist.

## **F. PHYSICAL SITE CHARACTERISTICS**

### **1. Hazards**

The subject parcel is not located in any defined area of hazard.

### **2. Floodplain**

FEMA Flood Insurance Rate Map panel number 08041C0558G which has an effective date of December 7, 2018, indicates that the site is not located within a regulatory floodplain.

### **3. Drainage and Erosion**

The proposed project is located within the Geick Ranch Basin (CHMS0400), which is not included in the El Paso County Drainage Basin Fee program. Therefore, drainage basin and bridge fees are not applicable.

A grading and erosion control plan, and drainage report will be required in the subsequent application.

### **4. Transportation**

The property is located north of Judge Orr Road and east of Elbert Road. The project proposes a vocational school campus which will significantly increase traffic on County facilities. According to the 2016 Major Transportation Corridors Plan Update (MTCP), corridor preservation for Judge Orr Road adjacent to the subject property is planned for a future two-lane principal arterial. A transportation impact study will be required in the subsequent application. Road Impact Fees, as outlined in Resolution 19-471, are applicable to the development and must be paid as per condition number three (3) under Recommended Conditions and Notation.



## **G. SERVICES**

### **1. Water**

Water service is to be provided by a community water system designed, engineered, and constructed by PPBOCES. Per the applicant's statements, PPBOCES owns all the water rights for the proposed campus and intends to design, engineer, and construct their own community water system, as well as extend central water services to the adjacent Jane Davis Ranch through a water services agreement. A Water Resources Report is being prepared by a hydrological engineer. This report will be required with the site development plan application.

### **2. Sanitation**

Wastewater service is to be provided by the Meridian Service Metropolitan District. A Will Serve Letter from the District will be required with the Site Development Plan application.

### **3. Emergency Services**

The site is served by the Peyton Fire Protection District.

### **4. Parks/Trails**

Land dedication and fees in lieu of park land dedication are not required for an Approval of Location. The El Paso County Community Services Department, Parks, and Recreation Division was sent a referral for the Approval of Location and had no outstanding comments.

### **5. Schools**

Land dedication or fees in lieu of school land dedication are not required for an Approval of Location.

- 1.** Approval of a site development plan by the Planning and Community Development Department is required prior to initiation of the proposed use and site improvements as depicted in the site plan Exhibit B and described within the letter of intent.
- 2.** No substantial expansion, enlargement, or modification of the site development plan shall be allowed except upon reevaluation and public hearing as specified in the El Paso County Land Development Code (as amended).
- 3.** Road Impact Fees, as outlined in Resolution 19-471, are applicable to the development and must be paid at the time of Site Development Plan approval.

## **NOTATION**

- 1.** Approval of Location requests are not forwarded to the El Paso County Board of County Commissioners for consideration. Pursuant to C.R.S. § 30-28-110, the final El Paso County action occurs at the Planning Commission.


# Aerial Map


# Zoning Map


# Placetypes Map






## Areas of Change Map





## **PPBOCES SERVICES AND PROGRAMS**

### **PPBOCES SERVICES:**

#### **Mental Health**

As required by Colorado state statute, when a rural School District is too small to be their own administrative unit for special education, they must belong to a PPBOCES. The SPED director for all nine County districts is a PPBOCES employee. PPBOCES provides school psychologists, social workers, and therapists for mental and behavior support to all nine districts, including school nurses, physical therapists, speech pathologists, O&M supports, signing para's for the deaf, and audiologists. Small rural School Districts cannot appropriate these services in their budget. PPBOCES co-ops these services to save money and be able to provide needed support. PPBOCES also has the Department of Corrections as a partner. The DOC provides SPED services to incarcerated youth under the age of 21 throughout 18 different correctional facilities statewide.

#### **Information Technology**

BOCES IT supports the technology needs of member districts through services such as technology consultations and web hosting.

#### **Professional Development**

Pikes Peak BOCES provides and hosts Professional Development.

#### **School of Excellence**

PPBOCES is unique in that it includes the School of Excellence and BOCES East. These two schools make up one of the largest mental and behavioral health schools for kids in Colorado. Students are staffed in the two schools from twenty-four School Districts including the Charter School Institute, grades K-12. When PPBOCES' IEP team and member Districts determine this is the best placement for the student, that student is then placed in PPBOCES' specialized programs. The goal is always to work with each student and have them return to their home District.

Presently, PPBOCES has approximately one hundred students in the School of Excellence and BOCES East with many more on waiting lists. With a lack of these programs available in El Paso County, PPBOCES is a valuable partner and program for all of our area School Districts.

#### **School to Work Alliance Program**

SWAP helps young adults find employment that interests them and which they are capable of doing and prepares them for successful employment.

## **Special Education**

The Pikes Peak BOCES special education teachers and specialists work with member districts under the supervision & evaluation of the BOCES directors to offer a variety of services for students with disabilities.

## **Two Year Alternative Licensure Program**

This alternative licensure program allows one to earn a salary while teaching in the classroom. Participants develop the knowledge and skills necessary to complete the program and concurrently earn a Colorado Initial Teacher License.

## **Workkeys Testing**

Pikes Peak BOCES offers testing for paraprofessionals through the ACT Workkeys. Testing covers basic mathematics, reading for comprehension and business writing.

## **PPBOTES PROGRAMS:**

### **SCHOOL TO WORK ALLIANCE PROGRAM (SWAP)**

The School to Work Alliance Program (SWAP) is designed to provide employment-related assistance to youth and young adults with disabilities, who are experiencing mild to moderate barriers to employment. Disabilities can take the form of physical, emotional, or learning disabilities. SWAP provides assistance that produces competitive, integrated employment outcomes and can help build career pathways for students through job exploration, work experiences, post-secondary exploration, workplace readiness skills, and self-advocacy instruction.

SWAP is a collaborative initiative between the Colorado Division of Vocational Rehabilitation (DVR) and local school districts and is supported by the Colorado Department of Education (CDE). The SWAP program provides case management and direct services to youth who:

- Have mild to moderate needs in employment.
- Are applicants of or are eligible to receive DVR services (meeting disability documentation requirements and able to benefit from the program).
- Need support to become competitively employed and to achieve successful community outcomes.

### **The Two-Year Alternative Licensure Program (2YALP)**

2YALP is operated by the Pikes Peak Board of Cooperative Educational Services (PPBOTES) and the University of Colorado at Colorado Springs Online and Academic Outreach. This alternative

licensure program allows one to earn a salary while teaching in the classroom and attending classes to gain the knowledge and skills necessary to complete the program and concurrently earn a Colorado Initial Teacher License.

### **Gifted & Talented Program**

Pikes Peak BOCES follows the National Association for Gifted Children mission of supporting those who enhance the growth and development of gifted and talented children through education, advocacy, community building, and research. The Program's aim is to support parents and families, gifted education team members, and their K-12 education professionals in the nine member Pikes Peak BOCES districts. PPBOTES believe that by working together it will achieve the vision where giftedness and high potential are fully recognized, universally valued, and actively nurtured to support children from all backgrounds in reaching for their personal best and contributing to their communities.

### **Early Access for Highly Gifted Students Program**

The Colorado Exceptional Children's Act (CECA) allows highly gifted students, who do not meet the age requirement for enrollment into kindergarten or first grade, to apply for Early Access into school. House Bill 1021 stipulates that districts may count in their enrollment and receive State Educational Funds for those highly advanced gifted students who meet the criteria established by Colorado. The district must abide by the rules promulgated by the State Board of Education. The district may charge a reasonable fee for the Early Access process.

District responsibilities: Provide early access information to parents. Educate teaching staff and community about Early Access Definition Early Access is defined as a highly gifted four-year-old child entering kindergarten, or a five-year-old entering first grade. A highly gifted child is defined as a gifted child whose body of evidence demonstrates a profile of exceptional ability or potential compared to same-age children. A child may be identified as gifted, but still not qualify for Early Access. To meet the needs of highly advanced development, early access to educational services may be considered as a special provision. Early access into school is regarded as a form of acceleration. The decision to accelerate a child can have a profound effect on a child's academic and social performance for the remainder of his/her school career. Therefore, Pikes Peak BOCES adheres to a thorough set of research-based procedures to determine if a child is eligible for Early Access.

### **PROPOSED PPBOTES EL PASO COUNTY CAMPUS LOCATION**

PPBOTES proposes to develop a new Campus on an 86.38-acre parcel it owns in the County at Judge Orr Road and Elbert Road. The parcel is vacant and undeveloped. It is zoned A-35 and is identified as a *Large-Lot Residential* placetype in *Your El Paso Master Plan*. It is in the vicinity

identified in the ‘Areas of Change’ and is adjacent to the *Employment Center* placetype and is centrally located within the County.

### **PPBOCES CAMPUS DEVELOPMENT PROPOSAL**

The Campus concept developed by the Applicant and PPBOCES will provide for new infrastructure at full build-out that will include buildings to facilitate PPBOCES’ mission and allow it to expand to serve students and staff through the services and programs it presently offers, and to develop new programs which will enhance its vocational training offerings to the twenty-three El Paso County member school districts it serves.

The Plot Plan for the proposed 86.38-acre Campus at buildout will include new vocational education facilities for the following:

#### **Instructional Facilities**

- Pikes Peak BOCES Administration Headquarters.
- Vocational Training.
- Construction Trades Training (e.g., carpentry, plumbing, electrical, etc.).
- Law Enforcement Training (in conjunction with the El Paso County Sheriff).
- Fire Fighting Training (in conjunction with the Falcon Fire Protection District and Peyton Fire Protection District).
- Medical Training (EMT training).
- Food Services Training (Culinary Arts).
- Veterinary Sciences Training (Animal Husbandry).
- Information Technology Training.
- Horticultural Sciences Training (Aquaponics, Greenhouse Management).

The PPBOCES Campus Approval of Location Plot Plan indicates these facilities, with internal streets, parking, and common areas, and will occupy approximately 52-acres of the overall 86.38-acre site.

These new training facilities will offer expanded services and programs to students within the member school districts in a consolidated and cohesive campus environment, versus being spread out in various other facilities throughout the County.

PPBOCES has always recognized that all students are not necessarily prepared for or able to participate in secondary education at the university or college level. For these students, the programs offered by the trade schools and training facilities which is an integral part of the PPBOCES vocational education program.

Presently, there is no BOCES Campus within the state of Colorado that is comparable to the one proposed for El Paso County. The Pikes Peak BOCES Campus concept will hopefully become a model for others to develop. The Campus has already received tremendous support from the Governor of Colorado, secondary educational institutions including Pikes Peak State College, and industry partners including trade unions, builders and contractors, and municipalities and school districts who benefit directly from a workforce trained by PPBOCES.

### **Campus Housing**

PPBOCES realizes the challenges of staffing this facility with qualified instructors and certified teachers. Unfortunately, it must rely on a very limited labor pool in a profession that is nationally recognized for below-average compensation. This makes it a challenge to recruit qualified professional teaching staff and instructors for the programs PPBOCES offers to its member school districts in El Paso County. To succeed, PPBOCES must offer competitive wages, incentives, and benefits to attract and retain staff.

PPBOCES also recognizes that housing costs alone in El Paso County (and throughout the Pikes Peak Region) have risen appreciably over the last several years. This makes it difficult, if not impossible, to attract professional teaching staff and instructors who simply are unable to rent or purchase homes as primary residences for themselves and family while employed at BOCES.

To address the huge disparity between wages paid to teachers and instructors and high housing costs (which is a significant deterrent to hiring staff), the PPBOCES Campus envisions offering primary residences to staff as part of their compensation and benefits package. The Plot Plan indicates up to 121 single-family residences proposed to be constructed on the Campus. PPBOCES, through its Construction Trades Program, proposes to build new single-family homes and offer them at substantially discounted (e.g., below market) rents to attract new instructors and teachers to PPBOCES. These new homes and related infrastructure are located on the balance of the 86-acre Campus not planned for vocational education facilities. PPBOCES will retain ownership of all homes it constructs on the Campus and include them as part of the compensation package offered to qualifying staff.

### **Campus Utilities**

The Campus will be served by a *Community Water System* (e.g., Public Water System), to be designed, engineered, and constructed by PPBOCES. A portion of the Campus will provide for a new water treatment facility that will extend water service to all facilities, housing, and irrigation to limited areas of the site. PPBOCES owns all water rights for its proposed Campus. A new commercial well will be provided which will sustain the PPBOCES Community Water System.

A *Water Resources Report* and *Water Information Summary Report* demonstrates that PPBOCES has adequate water to serve this development. The capacity of the proposed Public Water

System will also allow it to extend central water service to the adjacent *Jane Davis Ranch* via a Water Services Agreement between the owners of this developments and PPBOCES.

PPBOCES has been given approval by the **Meridian Service Metropolitan District** to be included in its wastewater treatment system. This will allow PPBOCES to provide a central sanitary wastewater system throughout the Campus. A Will Serve Letter to include PPBOCES in the District will be provided by MSMD.

### **THE PPBOCES CHALLENGE**

As indicated, there is no existing model for the PPBOCES Campus within the state of Colorado. The Campus proposed for El Paso County is a new concept, and PPBOCES hopes it will become a model for BOCES to emulate elsewhere in Colorado – and perhaps nationally.

Herein lies the challenge: as an institution that will provide learning and vocational education programs to students primarily in El Paso County in a unified campus environment, there are no definitive guidelines described in the *Your El Paso Master Plan* for a facility of the type for which Pikes Peak Board of Cooperative Education Services seeks approval. While the proposed PPBOCES Campus identifies and addresses planning and design criteria outlined in the *Your El Paso Master Plan* for multiple placetypes, there is no single placetype which offers the principles and goals envisioned for this application.

PPBOCES proposes to retain the site's current A-35 zone district and *Large-Lot Residential* placetype, while demonstrating that is addresses and satisfies the Vision and Goals defined in the *Master Plan* and provides a tremendous service to the County, PPBOCES' partners, and stakeholders.

This *Letter of Intent* attempts to justify the entitlement application with County planning criteria for a new facility that is wholly unique in El Paso County, and which serves a valuable community-wide benefit.

### **AREAS OF CHANGE**

*"The Areas of Change map in Your El Paso Master Plan indicate the BOCES site as located within the "New Development" Area of Change. It is identified as a "Large Lot Residential" placetype and is adjacent to an "Employment Center" placetype.*

*Over time, the County will focus on improving and enhancing existing placetypes and creating new placetypes consistent with the Master Plan. Building on the vision and goals of Your El Paso Master Plan, the different placetypes will take shape through community involvement, neighborhood planning, land use regulation, public investment, private investment, and public-private partnerships. [Your El Paso Master Plan]*

The PPBOCES Campus, as a new and unique placetype, aligns well with the County's focus of enhancing existing placetypes and creating new placetypes. While it does not specifically address the criteria for a *Large-Lot Residential* placetype, it does address and satisfy principles and goals defined in the *Your El Paso Master Plan* for multiple other placetypes including the *Employment Center* placetype to which it is adjacent.

The public-private partnerships with the seventeen School Districts in El Paso County, along with UCCS, Pikes Peak State College, and the anticipated new partnerships with the County Sheriff and two of the County's Fire Protection Districts exemplifies and satisfies the intent of this section of the Master Plan.

*"It is imperative that all development align with the placetypes to ensure the desired character of every part of the County, and provide appropriate density and use transitions to occur between differing placetypes." [Your El Paso Master Plan]*

The PPBOCES Campus provides an example of how a density and *use transition* between differing placetypes can be achieved. While the proposed Campus is not itself a use that might be considered for the *Large-Lot Residential* placetype, it does provide for planning and design characteristics which offer a transition between the *Large-Lot Residential* and *Employment Center* placetypes. PPBOCES will provide for development that is less dense than placetypes intended for mixed-use and commercial development. Yet open spaces of the Campus and clustered placement of housing, separated and buffered from adjacent *Large-Lot Residential*, are compatible with the intent of the "Areas of Change" described in the *Master Plan*.

#### **PLACETYPE: LARGE-LOT RESIDENTIAL**

*"This placetype still fosters a sense of community and is more connected and less remote than Rural areas. Large-Lot Residential neighborhoods typically rely on well and septic, but some developments may be served by central water and wastewater utilities. If central water and wastewater can be provided, then lots sized less than 2.5 acres could be allowed if, 1.) the overall density is at least 2.5acres/lot, 2.) the design for development incorporates conservation of open space, and 3.) it is compatible with the characteristic of existing developed areas." [Your El Paso Master Plan]*

---

The PPBICES Campus will be served by a central water system (Public Water System) and connected to existing central wastewater utilities. The overall site provides for approximately 27.5% (23.73 acres of the 86.38-acre site) open space at buildout, lending itself to a feeling of lower density.

Inasmuch as PPBICES is a public education facility and provides 27.5% of its Campus as open space, no additional parks or trails are proposed. An intramural sports field for use by member School Districts and the community may be provided as a future recreational amenity as indicated on the Plot Plan and may also serve a vocational opportunity for turf grass management as part of PPBICES' Horticultural Sciences program.

### **PLACETYPE: EMPLOYMENT CENTER**

*"The Employment Centers Placetype is the County's primary location for large-scale non-retail businesses and provide significant employment and economic development opportunities.*

*Some Employment Centers are located in Foreign Trade, Commercial Aeronautical, and Opportunity Zones to help incentivize development." [Your El Paso Master Plan]*

While the PPBICES Campus is adjacent to but not within the *Employment Center* placetype, it is located wholly within the County's *Opportunity Zone*. The Campus concept proposes for a moderate to large-scale non-retail facility which by the nature of the PPBICES Program provides significant employment and economic development opportunities. The Vocational Education training programs offered to students will help to provide significant employment and economic development opportunities in the County for students who successfully complete these programs.

### **PLACETYPE TRANSITIONS**

*"Placetypes are generally represented as they would be in the County geographically... while their representation in the Transition graphics is generally accurate, some placetypes could be located anywhere in El Paso County and are compatible with many different placetypes.*

*It is important to reemphasize the intended flexibility of the placetypes approach and their ability to morph over time as desires, needs, and opportunities dictate. Placetypes are not necessarily intended to be a linear transect, always existing from most to least development intensity. Placetypes of varying intensity can appropriately exist next to another given appropriate design, activity, and distance... Ultimately, the future is not entirely predictable and placetypes are the County's best approach to navigating the uncertainty in a way that can provide and safeguard desired character while addressing the needs of residents, businesses, and stakeholders as market conditions change and opportunities arise over time."*

*[Your El Paso Master Plan]*

---

The PPBOCES Campus concept presents a significant opportunity to all of El Paso County's School Districts, residents, and industry partners who rely on employees who have completed a BOCES program. As explained, the Campus concept does not fit into any one placetype. Yet it addresses the vital requirements and needs of stakeholders who need a trained workforce in a changing market.

The Campus concept can exist within the *Large-Lot Residential* placetype and is an example of the intent of how a placetype that is not a "linear transect" can be compatible with adjacent placetypes. In the few short years since the *Your El Paso Master Plan* was adopted by the County in 2021, the PPBOCES Campus proposal demonstrates the intent of how flexibility and the "ability to morph" to accommodate needs and opportunities can be achieved.

## **VISION**

*"Intergovernmental collaboration coupled with partnerships with external agencies will help maintain first-rate community facilities and provide high-quality services for all parts of the County. Coordination and collaboration will be critical to the management of the County's precious natural resources and ensuring their longevity for future populations. QA focus for utility services will be on establishing growth areas to prioritize future development to equitably manage water availability." [Your El Paso Master Plan]*

PPBOCES is a perfect example of how "*intergovernmental collaboration coupled with partnerships and external agencies can help to maintain first-rate community facilities.*"

PPBOCES' partnerships with the County's seventeen public School Districts, UCCS, and Pikes Peak State College and its projected collaborations with the County Sheriff and two Fire Protection Districts to expand the County's public safety, law enforcement, and emergency medical services (among several others) through its training programs will benefit all parts of the County. Establishment of a Sheriff's substation, Fire Protection substation, and Medical/EMT facility on the proposed PPBOCES Campus all help to ensure that these services are also available to benefit County residents.

As indicated, utility services including a Central Water System via an on-site PPBOCES-owned water treatment facility and central wastewater and sanitary services both are examples of how the PPBOCES Campus proposal will focus on establishing growth areas to prioritize future development and equitably manage water availability.

## **Priority Development Areas**

*"While some priority development areas may be made up of a mix of placetypes, each area is driven by a predominant placetype that defines most of the area." [Your El Paso Master Plan]*

The entire PPBOCES Campus is located within a portion of the County identified in the *Your El Paso Master Plan* as a 'Priority Development Area.' While the Campus is located within the *Large-Lot Residential* placetype, it is nearby and adjacent to a mix of other placetypes. As previously indicated, none of these other placetypes specifically is intended to accommodate the type of unique development proposed by this application.

## **HOUSING & COMMUNITIES**

### **Highway 24 Priority Development Area**

*"While an overall density of 2.5 acres per lot should be maintained within this area, consistent with the Large-Lot Residential placetype, denser development should be allowed if compatible with the existing development pattern and central water and sewer are being extended to provide a transition to expanding Suburban Residential development in Falcon..." [Your El Paso Master Plan]*

### **Increase Density in Target Areas**

*"The County should increase density in key areas to reduce the land cost per unit for development... Rural Center and Regional Center placetypes can accommodate more intense residential uses to increase support for businesses. Single-family and multi-family units should be located directly adjacent to commercial focal points to accommodate density in the County or incorporated within mixed-use developments." [Your El Paso Master Plan]*

The PPBOCES Campus application proposes denser residential development than what is typically associated with the *Large-Lot Residential* placetype as stated. Proposed housing development on the Campus is to be developed and owned by PPBOCES and will be made available to instructors and teachers as an employment compensation incentive through appreciably reduced rents.

Proposed housing development will occur on a portion of the Campus and will be *clustered* to increase efficiency of the proposed water treatment facility and Central Water System (and eventually central wastewater and sanitary sewer) infrastructure.

Homes to be developed on the Campus will be single-family and intended as rental units occupied by PPBOCES' professional staff. While the Plot Plan has been planned and designed to satisfy County planning criteria for front, side, and rear-yard setbacks established for small-lot residential subdivisions, the housing development area is intended as "community housing." This model will follow the *land lease* definition of development also known as a ground lease. This arrangement will allow PPBOCES as the landowner (e.g., the lessor) to rent out the land to a tenant (the lessee) who is intended to be PPBOCES professional teaching and instructor staff.

## **Accessory Dwelling Units**

*"Allowing alternative forms of density, such as small-lot homes or accessory dwelling units would provide more attainable housing units without altering neighborhood character." [Your El Paso Master Plan]*

For PPBICES to offer rental housing for professional staff as part of their compensation incentive, this application proposes small-lot homes to enable them to be economically viable to PPBICES. Clustering of the housing development portion of the Campus allows for an appreciable amount of open space to properties adjacent to the Campus. Small-lot [e.g. land lease homes] boundaries and lot lines are not immediately adjacent to larger lot homes in the *Large-Lot Residential* placetype that surrounds the Campus. Rather, to maintain neighborhood character of housing units adjacent to the Campus, small-lot and clustered homes will be developed next to no-build open space tracts and easements as indicated on the Plot Plan.

## **Permit Mixed Housing Type Development**

*"The County should permit projects that include a mix of housing types and increase market-driven affordability. [Your El Paso Master Plan]*

## **Workforce Development**

*"El Paso County has an established workforce with 74 percent of its workforce-eligible residents having jobs located in the County. The County should continue emphasizing developing quality, long-term job opportunities to capture local and regional workers. This should include efforts to promote upskilling throughout the County by connecting training and education to existing and future employers in target sectors and their needs." [Your El Paso Master Plan]*

PPBICES is an ideal example of how *Workforce Development* can be integrated into the County's overall economic plan. Proposed housing on the Campus connects training and vocational education in target sectors of the County and sustains emphasis on development quality and preserving long-term job opportunities for local and regional workers through increasing market-driven affordability which presently is lacking for teaching professionals.

## **Apprenticeships**

*"The Colorado Department of Labor and Employment (CDLE) provide a number of resources for industry-driven career pathways through apprenticeships..." [Your El Paso Master Plan]*

## **Growth Accommodation**

*"The County population has grown quickly and caused a significant need for additional schools for all grade levels... Further, the population is projected to grow in the future, which will continue to put pressure on education facility providers. Coordination is needed to support the educational system as it absorbs this growth..." [Your El Paso Master Plan]*

PPBOTES seeks to relieve the pressure placed on the County's education providers by providing new infrastructure that will accommodate the current requirements of School Districts and future growth. PPBOTES has demonstrated for decades that it can successfully support the education system by offering services and programs that traditional classrooms are not equipped and prepared to provide. The PPBOTES Campus addresses the need for additional schools at all grade levels in the County and offers support to the education system while absorbing growth.

*"To accommodate this growth the County should support efforts by the school districts to develop individual long-range capacity and facilities plans based on planned growth in El Paso County." [Your El Paso Master Plan]*

The PPBOTES Campus proposal is supported by the County's goal to accommodate growth which in turn supports the efforts of the seventeen PPBOTES-member school districts pertaining to long-range capacity and facilities plans.

*"These capacity plans should explore the feasibility of new construction and utilization of joint facilities that can be shared by elementary, middle, and high schools in the same district such as athletic fields or pods/mobile classrooms as supplements to permanent space. In addition, new construction of any educational facility should be strategic and planned out to meet the continued needs of the community..." [Your El Paso Master Plan]*

All seventeen of the participating PPBOTES-member school districts in the County will share newly constructed vocational education facilities proposed for the Campus. Students and the entire community will directly benefit from these new facilities. Services and programs to be provided by PPBOTES will be shared by elementary, middle, and high school students throughout the County.

## **Education**

*"There are 17 public school districts that provide primary education to students in both incorporated and unincorporated El Paso County." [Your El Paso Master Plan]*

## **CORE PRINCIPLES & GOALS** [Your El Paso Master Plan]

### **2. Housing & Communities**

**Core Principle:** *Preserve and develop neighborhoods with a mix of housing types.*

**Goal 2.3 – Locate attainable housing that provides convenient access to goods, services, and employment.**

### **3. Economic Development**

**Core Principle:** *Strengthen the economy with a skilled workforce and targeted investment.*

**Goal 3.2 – Support efforts to recruit, train, and retain a skilled workforce.**

### **4. Transportation & Mobility**

**Core Principle:** *Connect all areas of the County with a safe and efficient multimodal transportation system.*

**Goal 4.2 – Promote walkability and bikability where multimodal transportation systems are feasible.**

The following Goals for Community Facilities and Infrastructure are met by the proposed Pikes Peak BOCES Campus Approval of Location application:

### **5. Community Facilities & Infrastructure [Your El Paso Master Plan]**

**Core Principle:** Continue to coordinate with local and regional agencies to provide well-managed, high-quality community facilities and services.

**Goal 5.1 - Coordinate with agencies to provide high-quality community facilities, services, and infrastructure to enhance quality of life.**

**Goal 5.2 – Improve the effectiveness of public safety through coordination, funding, and planning.**

### **PROJECT LOCATION/DESCRIPTION AND HISTORY OF PROPERTY:**

PPBOCES purchased the 86.38-acre subject parcel with the intent to develop it as a vocational education training and technical trades campus to serve the County's seventeen School Districts, secondary education, and industry partners.

This Approval of Location application propose for the development of the following structures and uses:

- a) PPBOCES Administrative Office
- b) Classrooms and instructional space for multiple Construction Trade programs.
- c) A Fire Fighting Training Facility (which may also include a fire protection substation to serve the surrounding community).

- d) Sheriff Substation and Training Facility (which may also include a law enforcement substation to serve the surrounding community).
- e) Medical Clinic and Training Facility (which may also include Emergency Medical Technician services to serve the surrounding community).
- f) Vocational training facilities for carpentry, plumbing, electrical professions, and construction equipment operation.
- g) Veterinary Clinic and Training Facility.
- h) Culinary Arts/Bakery, and Food Services Training Facility.
- i) Horticultural Sciences Training Facility.
- j) Workforce Housing development with up to 121 homes, owned and constructed by PPBOCES in conjunction with its technical trades program (Campus housing is intended for instructors and staff to be offered as an incentive as part of their compensation package).

The PPBOCES Campus Plot Plan property is located in El Paso County (Peyton, CO) approximately 20 miles northeast of downtown Colorado Springs, situated approximately two miles east of Colorado State Highway 24 and 3 miles west of Peyton Highway on the northeast corner of Elbert Road and Judge Orr Road. The site roughly extends from Elbert Road east along Judge Orr Road and has approximately 2,630 feet of frontage along Judge Orr Road.

As stated, *Your El Paso Master Plan* identifies the placetype of this development as “*Large Lot Residential*” and is adjacent to the “*Employment Center*” placetype described in the Master Plan.

Commercial Retail/Commercial Services, and Parks and Open Space are also allowed as support uses. Residential lot development, within the Large Lot Residential placetype, allows for lots having a minimum area consisting of 2.5 acres or more. This placetype is more connected and less remote than the *Rural Placetype* that comprises the larger eastern half of the county. The PPBOCES Campus Site Plot Plan proposes for up to 121 single-family dwelling units lots to be owned by PPBOCES and offered at appreciable rental discounts as a compensation incentive to instructors and teachers employed by PPBOCES, as described in the “*Housing & Communities*” paragraphs of this Letter of Intent.

The *Master Plan* identifies the entire PPBOCES Campus property as being within the County’s Priority Development Area. Highway 24 is a major roadway that connects the northeastern part of the County to Colorado Springs. Significant growth is expected along the corridor between Falcon and Peyton not only to connect the existing subdivisions, but also to capitalize on proximity to the Highway and the Falcon Regional Center. *Your El Paso Master Plan* suggests for an overall density of 2.5 acres per lot to be maintained within this area, consistent with the *Large-Lot Residential* placetype, although denser development within this area of the Falcon/Peyton area can be considered.

Based on FEMA FIRM number 08041CO5596 dated December 7, 2018, the large drainageway near the site is a ‘Zone A’ FEMA floodplain. Zone A is defined as an area within the Special Flood Hazard Area (SFHA) with no base elevations determined.

Walking paths, trails, and other designated routes as indicated will be provided on the Campus to reduce the need for automotive travel between the vocational education facilities and residences. Additional access and extensions with connectivity to recreational spaces may be provided when development occurs.

**Core Principle 7: Maintain and expand the County’s recreation and tourism options.**  
**Goal 7.3 - Plan for and provide a variety of parks, trails, and open space within the region.**

***Large-Lot Residential Within the Large-Lot Residential Placetype***, conservation design should be primarily utilized for preserving El Paso County’s rural character, defined by large swaths of open space with minimal development. Additionally, some Large-Lot Residential parts of the County include environmentally sensitive areas that need to be protected. Development should not be allowed within a certain distance of the critical natural assets to ensure they are not negatively impacted by future development. Protecting farmland and scenic views is also an important component of conservation design within Large-Lot Residential areas. The County should evaluate new developments on a case-by-case basis to determine their impact on these natural assets. [Your El Paso Master Plan]

## **DEVELOPMENT REQUEST**

The PPBOCES Approval of Location application is being sought without any waiver or deviation requests. The zoning will remain A-35 zoning.

Residences to be developed by PPBOCES will be of the “Land lease” type; PPBOCES will retain ownership and provide maintenance for all residential dwellings. Individual lots for each new residence satisfy all El Paso County setback criteria for an urban density subdivision.

Pursuant to this Approval of Location application, the applicant proposes to develop the site with up to one hundred and twenty-one (121) new residences, ten to eleven administrative and vocational education support facilities, and a Water Treatment Facility to serve the central water system proposed for the entire PPBOCES Campus. New development is proposed for this 86.38-acre site, of which approximately 25.12 acres will be developed as administrative, vocational education support, and a water treatment facility. 24.90 acres will be developed as single-family residential units for PPBOCES instructor and teaching staff.

An intramural sports field may be developed on the site in the future (as indicated on the PPBOTES Approval of Location Plot Plan) for use by member school districts and the community. The balance of the site will include internal private streets, surface parking lots for all vocational education support facilities, open spaces, an existing 150' electric transmission easement (owned by MVEA) on the east and north boundaries, and detention. In the event PPBOTES is unable to connect to an existing Metropolitan District wastewater/sanitary line to provide a central community sanitary system for the Campus, an on-site wastewater treatment system (OWTS) will be developed; additional space needed to accommodate an OWTS is available.

Infrastructure to serve the new lots, including private roadways, driveways, drainage improvements, and utilities will all be constructed in compliance with applicable County standards, regulations, and criteria in effect at the time of this application. This is in keeping with the rural character of the surrounding Falcon/Peyton communities.

Surrounding properties are presently undeveloped, or approved for development of rural, single-family homesites on 2.5 and 5.0-acre lots. A few commercially-zoned parcels are proposed for the adjacent Jane Davis Ranch and Esteban Rodriguez Subdivision. These parcels are proposed for smaller commercial service uses and will primarily provide neighborhood retail uses for nearby communities.

Land use within these properties has traditionally been ranchland with some farming. Existing Planned Unit Development (PUD) zoning is also located within a 2-mile radius of the PPBOTES Campus site.

#### **JUSTIFICATION FOR REQUEST**

This request is consistent with the purposes of the *2021 Your El Paso Master Plan*. The PPBOTES Approval of Location application is in conformance with subdivision design standards and establishes an adequate level of compatibility with surrounding areas of the site already constructed and other known surrounding areas currently proposed for development, particularly the existing 816-acre *Saddlehorn Ranch* (e.g., 218 lots zoned RR-2.5) at Judge Orr Road and Curtis Road immediately west of and adjacent to the subject property, the proposed 398.91-acre *Jane Davis Ranch* (e.g., pending application in progress to approve approximately 92 lots to be zoned RR-2.5 and RR-5.0) also immediately north of the subject property, and the proposed 496-acre *Esteban Rodriguez Subdivision* (pending application in progress to approve approximately 142 lots to be zoned RR-2.5 and RR-5.0).

Primary access/egress to the PPBICES Campus will be from Elbert Road and Judge Orr Road. Connectivity to the Campus and proposed Jane Davis Ranch is proposed on Elbert Road, and the proposed Esteban Rodriguez Subdivision on Judge Orr Road. All intersection spacing for points of access are in accordance with County standards and no waivers are requested.

### **EXISTING AND PROPOSED IMPROVEMENTS**

The PPBICES property is vacant, and no improvement has been made to it. PPBICES intends to be the developer of the site and will be responsible for construction of new internal roads, drainage structures, utilities, and other infrastructure as required by the County.

Electric and telecommunication service points-of-connection will be extended from the roadways. Extension of natural gas service will be sought from Colorado Springs Utilities, who already provide service to the adjacent Jane Davis Ranch development. Water will be provided via a central water system (Community Water System/Public Water System) to be designed, engineered, and constructed by PPBICES in accordance with El Paso County Department of Health policy guidelines. The applicant is presently seeking to have the PPBICES Campus be served by an existing Metropolitan District for wastewater/sanitary.

***Incorporating Water-saving Actions in Land Use & Development Planning in El Paso County***

*Discourage individual wells for new subdivisions with average lot sizes smaller than 2.5 acres when there is a reasonable opportunity to connect to an existing central system or construct a new central water supply system when the economies of scale to do so can be achieved, especially in the Laramie-Foxhills, Lower Arapahoe, Denver and Lower Dawson aquifers.*

Grading and earthmoving activities will be limited to building pads, internal streets, driveways, drainage, and utility construction areas. ‘Overlot’ grading is not proposed to occur over most of the site.

As such, prior to construction of proposed structures, lot-specific subsurface soil investigations will be performed to determine whether shallow groundwater, hydro-compacted soils, and/or potentially expansive soils are present on the lot, and to determine an appropriate foundation design, basement, or crawl-space suitability, and/or lot-specific recommendations are necessary to mitigate these conditions.

### **NO-BUILD / OPEN SPACE / RESIDENTIAL LOT OPEN SPACE EASEMENTS**

**Per Section 4.2.6.F.8c. of the Land Development Code:** Calculation of Residential Open Space of the El Paso County Land Development Code: “*individual, private residential or commercial lot areas shall not be included on the open space calculation unless the open space areas located on private lots are subject to open space easements and restrictions.*”

Any “Floodplain – No Build / OS” tract into which some new development may encroach are included in the PPBOCES Campus Site Plot Plan calculations as “*Private Open Space*” areas. Lots that encroach into the “Floodplain – No Build / OS” tracts will be designated as open space easements in future development submittals. These areas shall remain Private Open Space in perpetuity with no construction of primary and ancillary structures, sheds, barns, fences, etc., permitted within any no-build private open space area.

The PPBOCES Campus Plot Plan proposes a combination of public and private open spaces. Public open space will include an athletic field site, detention pond parcels, and trail easements located within certain easement and buffer areas to provide connectivity to the County’s private open space easements and public open space areas.

Public Open Space areas will be maintained by PPBOCES. Private Open Space areas will be maintained by the owner on whose lot the Open Space easements may be located.

## **ADHERENCE WITH THE 2021 YOUR EL PASO MASTER PLAN, AND WATER MASTER PLAN**

***Land Use & Development, Core Principle:*** Manage growth to ensure a variety of compatible land uses that preserve all character areas of the County.

The 2021 Your El Paso Master Plan (the “Master Plan”) addresses issues directly related to the BOCES Campus Site Approval of Location application. Policies specifically related to this Plot Plan request include:

**Goal 1.4 – Continue to encourage policies that ensure “development pays for itself.” [Your El Paso Master Plan]**

All infrastructure for the Campus will be developed and paid for by PPBOCES.

***Housing & Communities, Core Principle:*** Preserve and develop neighborhoods with a mix of housing types. [Your El Paso Master Plan]

**Goal 2.2 – Preserve the character of rural and environmentally sensitive areas.**

The project’s open “campus” design with A-35 zoning for the site is compatible with the lower density character of adjacent and nearby neighborhoods that are zoned RR-2.5, RR-5.0, A-35, and A-5.

***Transportation & Mobility, Core Principle:*** Connect all areas of the County with a safe and efficient multimodal transportation system. [Your El Paso Master Plan]

**Goal 4.1-Establish a transportation network that connects all areas to one another, emphasizing east-west routes, reducing traffic congestion, promoting safe and efficient travel.**

The design of the PPBICES Campus will locate new home driveways with direct access onto proposed paved internal private residential collector streets. Up to 121 proposed residences will have driveways off these internal residential collector streets for access; no direct driveway access for any new lot is planned for Judge Orr Road or Elbert Road to minimize any increased traffic load from new lots onto these existing arterials.

**Community Facilities & Infrastructure, Core Principle:** Continue to coordinate with local and regional agencies to provide well-managed, high-quality community facilities and services. [Your El Paso Master Plan]

**Goal 5.3 – Ensure adequate provision of utilities to manage growth and development.**

Future Development Plan/Final Plat submittals of the PPBICES Campus will seek commitment letters for delivery of electrical service and natural gas from established utility providers in the vicinity. An on-site commercial well will provide water to a proposed Water Treatment Facility to be developed and owned by PPBICES. A central “community water system” [e.g., Public Water System] will be developed to extend domestic water service to all proposed PPBICES buildings and residential units also proposed for the site. A Water Resources Report prepared by a hydrological engineer accompanies the Approval of Location and Exemption Plat applications.

Based upon evaluation by environmental and geotechnical engineers, it has been determined that the site is suitable for an individual on-site wastewater treatment system (OWTS) without contamination of surface and subsurface water systems. However, PPBICES has been accepted into the Meridian Service Metropolitan District which will enable PPBICES to participate in the District’s wastewater and sanitary service. PPBICES will provide design and engineering services to extend sanitary sewer from the PPBICES Campus site at Judge Orr Road and Elbert Road to that District’s sanitary service. A Will Serve letter from MSMD is included with this application.

**Goal 5.4-Use best management practices to protect water quality, conserve water, minimize impacts of flooding, and beautify El Paso County.**

The drainage report specifically details a four-step process to minimize adverse impacts of development. The process includes reducing runoff volume, stabilizing drainageways, treating the water quality capture volume (WQCV), and considers the need for Industrial Commercial best management practices (BMPs).

**Environment & Natural Resources, Core Principle:** Prioritize and protect the County's natural environment.

**Goal 9.2- Promote sustainable best practices with regard to development and infrastructure.**

The area surrounding the property has sufficient carrying capacity to support the new development projected roadway capacity, water supply, septic suitability, vocational education facilities, and organized structural fire protection. Commitment Letters from entities that would supply this development with essential services will be sought and provided at future levels of Development Planning/Final Platting.

The PPBOCES Campus Plot Plan design, which provides for up to 121 new single-family dwelling units for PPBOCES instructors and staff and open space uses ensures that development of this site will remain compatible within the nearby community.

### **GAS SERVICE**

The applicant will seek natural gas service by utility service providers already established in the vicinity at future levels of Development Plan/Final Platting.

### **WATER SERVICE**

The following information is provided by request of El Paso County per the *El Paso County Water Master Plan, Chapter 7, Implementation*:

#### **Water Quality, Quantity and Dependability:**

A Water Resources Report and Water Supply Information Summary have been prepared which provides data for the Planning Commission and the Board of County Commissioners (BoCC) which confirms the proposed water supply for the PPBOCES Campus is sufficient in terms of quality, quantity and dependability for the proposed subdivision. The report includes documentation that the proposed water supply is sufficient in terms of quantity, dependability and quality for the proposed subdivision.

The PPBOCES Campus will provide for single-family residential development intended for instructors and teaching staff as part of their compensation package (PPBOCES will retain full ownership of all homes developed on the Campus). The proposed development is comprised of one parcel which is owned by the Pikes Peak Board of Cooperative Educational Services. The total acreage of this parcel is 86.38 acres.

The subdivision is proposed to be developed with up to 121 residences, and multiple public facility buildings (vocational education instruction and classrooms), and a water treatment facility. All residences and public facilities will be served by an on-site commercial well drilled into the not-nontributary Denver aquifer below the PPBOCES Campus property. The proposed subdivision lies within the Upper Black Squirrel Creek Designated Groundwater Basin and is managed by the Upper Black Squirrel Creek Groundwater Management District.

The water quality in the Denver aquifer formation in this area has typically been suitable for residential potable use. Water samples were obtained from an existing well (well permit #163012-F) constructed via an exterior hose bib existing on the side of the house located at 9350 Elbert Road (*Jane Davis Ranch*, adjacent to the PPBICES Campus). Water samples were obtained from this tap on 04/04/2023, with water quality testing performed Colorado Analytical Laboratories and Hazen Research, Inc., per the El Paso County Land Development Code section 8.4.7(B). All results were found to be below primary and secondary Maximum Contaminant Limits (MCLs).

Because of the absence of all evidence of fecal contamination in the form of E. Coli or Total Coliform, or that all sampled and analyzed constituents were below all primary and secondary standards, the proposed water source emanating from the Denver Aquifer is deemed safe for public consumption.

### **TRANSPORTATION**

The PPBICES Campus Plot Plan provides for two separate points-of-access from Judge Orr Road into the community. No lots adjacent to Judge Orr Road are proposed to have direct access/egress onto Judge Orr Road and will be accessed via internal roadways.

***Subdivision Access*** Local access is key to connecting residents to the region and residents have identified subdivision access as a primary concern. Input received as part of Your El Paso County outreach process cited a need for subdivision communities to have two points of access, or two ways in and out. Generally, single access subdivisions create points of high traffic and congestion where they join the primary street network and are disconnected from other neighborhoods by roads that dead end at cul-de-sacs. Having two points of access allows for a more contiguous street network and would remove these barriers.

Walking trails indicated on the Plot Plan help to provide connectivity throughout the PPBICES Campus, and to encourage walking and bicycling in the community while effectively reducing vehicular travel – especially to classrooms, open spaces, and vocational education buildings.

***Providing multiple points of access to a subdivision*** also improves efficiency in emergency response times and allows for better pedestrian and bicycle access across neighborhoods. Better access can be the difference between a resident or visitor choosing to walk over drive to their destination. Increased access, especially with multimodal options for walking and biking could reduce vehicular travel and ultimately congestion and stress on roadway infrastructure.

### **TRANSPORTATION IMPACT STUDY GUIDELINES**

A Master Transportation Impact Study (TIS) will be submitted for this project at a future level of development panning and will be based upon the El Paso County Engineering Criteria Manual (ECM) per ECM appendix B.1.1.

PPBICES anticipates phased development of the Campus over a multi-year build-out (six separate phases are planned for as of this application date).

### **ROAD IMPACT FEES**

Per resolution 19-471 Road Impact Fees are applicable and due for this project.

### **CHAPTER 7 AND CHAPTER 8 OF THE LAND DEVELOPMENT CODE CRITERIA FOR APPROVAL**

The proposed subdivision is in general conformance with the goals, objectives, and policies of the 2021 Your El Paso Master Plan.

The proposed subdivision is in conformance with the requirements of this Code; no waivers or deviations from the Code are requested or proposed.

The proposed subdivision is compatible with existing and proposed land uses within and adjacent to the Plot Plan area; as previously described, The Plot is in conformance with subdivision design standards and establishes an adequate level of compatibility with surrounding areas of the site already constructed and other known surrounding areas currently proposed for development, particularly the existing 816-acre Saddlehorn Ranch (e.g., 218 lots zoned RR-2.5) at Judge Orr Road and Curtis Road immediately west of and adjacent to the subject property, and the proposed 398.91-acre Jane Davis Ranch (e.g., pending application in progress to approve approximately 92 lots to be zoned RR-2.5 and RR-5.0) also immediately north of the subject property.

The design with A-35 zoning for the site is harmonious and compatible with the lower density character of adjacent and nearby neighborhoods that are zoned RR-2.5, RR-5.0, A-35, and A-5.

The Water Supply Report provides sufficient information to identify probable compliance with the water supply standards and identifies any need for additional water supplies; A Water Resources Report and Water Supply Information Summary will be provided to the County with a future development application. The Water Resource Report prepared for the PPBICES Campus will provide data for the Planning Commission and the Board of County Commissioners (BoCC) which confirms the proposed water supply for the PPBICES Campus is sufficient in terms of quality, quantity and dependability for the proposed subdivision. The report includes documentation that the proposed water supply is sufficient in terms of quantity, dependability and quality for the proposed subdivision.

Services are or will be available to meet the needs of the subdivision including, roads, police and fire protection, schools, recreation facilities, and utility service facilities.

The soil is suitable for the subdivision and any geologic hazards do not prohibit the subdivision and can be mitigated; A Geological Hazard Report and Soils Report has been prepared for the PPBOCES Campus Site Plot Plan. No known geological hazards are present which may preclude the site from development as proposed. As described previously, existing drainageways will be mitigated and preserved as private open space tracts, all of which will be designated as no-build areas.

The subdivision will not interfere with the extraction of any known commercial mining deposit [C.R.S. §§ 34-1-302(1), et seq.]. No known commercial mining operations exist on the site. An *Affidavit of Notification to Severed Mineral Estate Owners* has been submitted with this application.

The design of the subdivision protects the natural resources or unique landforms; existing natural resources and unique landforms will be protected and designed to be within no-build areas. There are no known natural resources or unique landforms on the site.

The proposed methods for fire protection are adequate to serve the Campus; the Peyton Fire Protection District will extend service within the PPBOCES Campus Site Plot Plan area. A Letter of Intent to Serve the PPBOCES Campus will be provided by the Peyton Fire Protection District at a future level of planning and submittal.

## SUMMARY

The Campus designation for this site is appropriate, and the design is based on mitigating the constraints of topography, soil types, geologic hazards, aggregate resources, environmental resources, floodplain, airplane flight overlays, or other constraints; there are no known environmental or other constraints that would preclude development of this site as proposed in the Plot Plan. Topography, soil types and geologic hazards and other environmental resources are not compromised by the development of this site. The entire property is outside of any airport overlay zone, including Meadow Lake Airport and the Colorado Springs Municipal Airport (Note: despite this, the owner is agreeable to including a *Notice of Avigation Easement* to the Plot Plan).







## Q1 What grade are you in?









# Many teens are rethinking college. This 87-acre campus near Colorado Springs wants to help them find careers without it.

As student interest surges in careers that don't require a college degree, superintendents want to build an education park where they can explore vocational training and job certifications

**E**L PASO COUNTY — Across 87 acres of sprawling fields near Colorado Springs, a group of Colorado superintendents is setting out to revive schooling in the trades and expand students' options beyond college — preparing them for jobs in industries battling steep workforce shortages and even training kids interested in construction to one day build affordable teacher housing close by.

It's all part of a plan that education leaders who belong to the Pikes Peak Board of Cooperative Educational Services have been dreaming up for the past four years, motivated by a resurgence in career and technical education (CTE) and a growing need for skilled employees among local companies.

The Pikes Peak BOCES — which provides support, staffing and resources to nine rural districts and 12 bigger districts and other school agencies — is in the early stages of creating what it calls the **Pikes Peak BOCES Education Park**. It will be a kind of CTE campus where regional students will have new opportunities to explore what it takes to pursue well-paying careers in a range of fields that don't require a college degree: construction trades, firefighting, veterinary training, food services and culinary arts, cybersecurity, horticulture science, meat sciences and medical services.

The budding CTE hub helps answer one thorny question weighing on districts, students and business owners: What will it take to build up the state's future pipeline of workers and connect kids with meaningful careers?

"The pendulum is starting to shift in Colorado to the point that our kids, especially our rural kids, are saying, 'Hey, college isn't really working for me,'" said Pat Bershinsky, executive director of the Pikes Peak BOCES.

He noted that more parents are also steering their kids toward vocational careers and certification programs.

"I think it's prime for us to do something like this," Bershinsky said.


The central CTE park will give rural school districts a better footing to expand the kinds of programs they can offer their students, particularly as smaller remote districts often struggle to find qualified CTE teachers willing to instruct students — teachers whom Bershinsky

calls “unicorns.” Those same districts also tend to have a hard time piecing together the funding needed for extra CTE programs, he said.

The park will allow districts to share CTE teachers and pool their funding at a time “there’s just this huge need, especially on the backside of COVID, for skilled workers,” he said.

Bershinsky kick-started the project by purchasing 87 acres with \$870,000 the BOCES gained after selling a school building back to Calhan School District RJ-1 and also securing a \$2 million Rural Coaction Program grant distributed by the Colorado Department of Education. Those funds have helped set planning in motion, including by sending superintendents to scout out vocational facilities in Cherry Creek as well as Las Vegas and Stillwater, Oklahoma, by hiring architects to design an initial layout for the park and by conducting water studies.

Bershinsky hopes to break ground on the park sometime early next year, focusing first on a centralized water facility and one building that would house construction trades along with a 911 dispatch training center and a cybersecurity training center. The cost for the initial infrastructure, water facility and first building is an estimated \$14 million.

Bringing the campus to life will require more money, which is why Bershinsky said he plans to apply for an Opportunity Now Colorado grant through a state program that helps fund the rollout and expansion of workforce development initiatives.

He has also pinpointed another potential revenue stream: selling water from the park's centralized water facility to a nearby 400-home development awaiting construction.

He's eager to get shovels into the ground.

"Every year that passes that we can't (start building)," Bershinsky said, "we're just missing another group of seniors that could benefit."

## **Workforce shortages are only worsening but perceptions of CTE careers are changing**

For now, districts that are part of the Pikes Peak BOCES are starting to scale up their own CTE programs that will eventually feed into the education park. Ellicott School District 22 earlier this school year partnered with a local union of plumbers, pipefitters and HVAC technicians to introduce a pre-apprenticeship program through which students can learn plumbing, sheet metal fabrication and welding skills.

Meanwhile, high schoolers from a handful of Colorado Springs-area districts have begun learning how to answer emergency phone calls while **studying how to become a 911 dispatcher.**

And in August, Miami-Yoder School District 60-JT — a district of more than 400 students in preschool through 12th grade in Rush — will launch a program instructing kids how to operate heavy equipment, starting them on a four-year apprenticeship so that they can knock out one year while still in high school.

Students who attend Miami-Yoder School District are scattered across 420 square miles in three counties without much of a city nearby. Rush has a church, a café, a post office, a food pantry and a part-time mechanic.

Despite sitting in an isolated part of Colorado, the district prioritizes six CTE programs within its one school building, said Superintendent Dwight Barnes, and almost half the district's teaching staff focus on CTE. The district also shuttles students to Pikes Peak State College for a half day of learning CTE skills and working toward certifications in fields like welding and catering.

Barnes has been lucky in retaining most of his CTE instructors, who specialize in agriculture, criminal justice, information technology, family and consumer sciences, audio production and graphic design. Finding educators is the biggest challenge district leaders face in building CTE programs, he said.

But he and his staff have had to devise ways to round out their students' classes with work-based learning opportunities. Audio production students, for example, help set up and get equipment rolling for school events while catering students have assisted in the school kitchen.

"We try to be creative here because it's all I have," Barnes said. "There's nothing around."

That's why the education park appeals to him. Students can hop on a bus and travel 35 minutes to spend a half day of school at the park, gaining confidence in their CTE skills and applying those skills in a work-based setting so that "they've been able to experience that job before they ever go out (to an employer) at 18," Barnes said.

"It puts everything right there together," he said.

Bershinsky sees promise in also opening up the education park to students from the BOCES' School of Excellence, which educates kids who have significant special needs and kids who struggle with behavioral challenges. Often, those students run into limited options to train for a job that would allow them to make a living after high school, Bershinsky said. He plans to relocate that school to a new building right on the CTE campus.

"Our kids in this building could benefit from these programs," he said. "My kids don't get the same opportunity as other kids in other districts, and the reason why is that kid comes with a behavior or comes with a disability and if they try to get into some of these vocational programs, they're turned away."

And once some of the trades programs are more established at the CTE hub, Bershinsky envisions that students learning construction will be able to walk to the east side of the property and put their skills to work by helping build affordable housing for teachers and school district staff.

It's one way to make a dent in the astounding workforce shortages overtaking Colorado's construction industry, which will have an estimated 45,000 jobs to fill by 2027, according to data from the nonprofit Construction Education Foundation.

"Clearly, there's no pipeline really with enough people to fill those positions," said Tony Milo, president and CEO of the Colorado Contractors Association. "We've had a shortage for the last few years, and it's only getting worse."

That shortage has largely been fueled by increased investment in infrastructure in Colorado and nationally, Milo said, noting, "we don't have an increase in workers so that's exacerbating the workforce shortage problem."

Schools haven't necessarily helped produce more construction workers in the past 20 years, he added, but that's slowly changing — along with perceptions of pursuing construction as a career.

"Now with college debt continuing to skyrocket and continuing to be an issue," Milo said, "people are starting to open their eyes to other opportunities that don't incur college debt, and construction is really one of those careers."

Still, he anticipates it will take a decade to build an adequate pipeline of construction workers across the country as baby boomers retire "at a rapid pace."

That means that construction companies will continue struggling to grow and take on more projects while the state will continue facing challenges with finding enough workers to maintain roads, bridges and transportation systems.

“That’s why it’s really important for us to invest in these CTE programs,” Milo said, “and really help train and expose young people to the many great careers that are available in the industry.”

## Gov. Polis hears plans for \$14M trade school campus northeast of Colorado Springs

The planned 87-acre Pikes Peak Education Park will provide tuition-free "high-quality, career-connected" training for teens and young adults

Southern Front Range education leaders presented their collective vision for a multimillion-dollar trade school campus northeast of Colorado Springs to a visiting Gov. Jared Polis on Friday.

They described the planned 87-acre Pikes Peak Education Park as the solution to a growing demand for skilled workers, a dearth of qualified grads, and a generation of teens and young adults poised to enter the workforce but lacking direction and accessible training opportunities.

Initial \$14 million build-out on the project is set to begin early next year on land previously purchased by the Pikes Peak Board of Cooperative Educational Services (BOCES) at the northeast corner of Judge Orr Road and Elbert Road.

The planned education park will provide tuition-free “high-quality, career-connected” training in a range of trades that high school students can learn while also earning credits toward graduation at their home schools.

“There’s a huge need for culinary arts … (law enforcement) dispatch, community service … (and) it’s going to sound odd to you, but I fully intend on putting a meat-processing facility there, because we don’t have one in the state of Colorado to train kids how to cut meat,” said Pat Bershinsky, executive director of Pikes Peak BOCES.

“I can envision a day when we’re slaughtering cattle for local ranchers.”

Bershinsky imagines the array of training offered as ever-evolving alongside community and business needs, he said. Partnerships with unions and trade groups already are a core piece of the project.

The heart and soul, however, are the students the park hopes to bring in.

“If we can get these kids going, whether it’s dispatch, community service specialist, kitchen or culinary … it’s a pipeline” to getting them into much-needed jobs in the community, Bershinsky said.

Last November, voters in Colorado Springs rejected a city plan that proposed setting aside almost \$5 million to establish a new police academy.

Programs offered at the new education park could help train workers for careers that support law enforcement and set them up to continue in the field, Bershinsky said.

“I would love to envision a day where we have 50 or 60 kids in these, dispatch training, criminal justice training, and by the time they’re 21, we’re starting to fill a huge need with our local sheriff’s office.

“It’s not just about employers and filling jobs.”

Calhan Superintendent Dave Slothower said the new education park will address one of the biggest hurdles rural students face when trying to chart a course for a living-wage future.

"At the heart of this is ... putting that training opportunity in our area that we can access more easily," Slothower said. "The biggest obstacle we face in getting our students to the job site, to the training site, is proximity."



The BOCES program focuses on supporting students in rural districts surrounding the Springs, including Big Sandy, Calhan, Edison, Elbert, Ellicott, Hanover, Miami Yoder and Peyton, but the Education Park's courses will be open to all district students, Bershinsky said.

The park also will house the relocated home of the Colorado Springs School of Excellence, which serves students with diverse social, emotional and behavioral needs.


Bershinsky said the choice of property — in the “middle of nowhere” — was “by design.”

Given the exponential growth of Colorado Springs and already-approved construction projects on the near horizon, it won’t be the middle of nowhere for long.

If Pikes Peak BOCES were to establish a central water system to support the school, future homeowners in the area could pay to tap in, providing a vital financial pipeline for the project.


“At the end of the day, part of the discussion has been ... we struggle for money,” Bershinsky said. “I think if we can do something like this, it makes us different and it puts us in a position where we don’t struggle for money anymore.”

Polis listened to the visions and projections for the near future Friday, and offered an educated heads-up about what may be to come.



"It probably means there will need to be a (new) elementary school sooner rather than later, if there are 500 families moving in in the next couple years," he said.

WHEREAS, Pikes Peak Board of Cooperative Educational Services ("PPBOCES") did file an application with the El Paso County Planning and Community Development Department for an Approval of Location to allow for the placement of an 86.38-acre campus comprised of secondary education facilities for vocational training, campus housing, and a community water system on property in the unincorporated area of El Paso County as described in Exhibit A and depicted in Exhibit B, attached hereto and incorporated herein by reference; and

WHEREAS, a public hearing was held by this Commission on August 15, 2024; and

WHEREAS, based on the evidence, testimony, exhibits, consideration of the Master Plan for the unincorporated area of the County, presentation and comments of the El Paso County Planning and Community Development Department and other County representatives, comments of public officials and agencies, comments from all interested persons, comments by the general public, and comments by the El Paso County Planning Commission members during the hearing, this Commission finds as follows:

1. That the application was properly submitted for consideration by the Planning Commission;
2. That proper posting, publication, and public notice were provided as required by law for the hearing before the Planning Commission;
3. That the hearing before the Planning Commission was extensive and complete, that all pertinent facts, matters, and issues were submitted, and that all interested persons and the general public were heard at that hearing;
4. That the authorization or financing of said public way, ground, space, building, structure, or utility does not fall within the province of the Board of County Commissioners;
5. That the application conforms to the El Paso County Land Development Code;
6. That the application conforms to the adopted El Paso County Master Plan;

1. Approval of Location requests are not forwarded to the El Paso County Board of County Commissioners for consideration. Pursuant to C.R.S. § 30-28-110, the final El Paso County action occurs at the Planning Commission.


