1. This letter is being sent to you because Liberty Tree Academy is proposing a land use project in El Paso County at 8579 Eastonville Road in Peyton, CO. This information is being provided to you prior to a submittal with the County. Please direct any questions on the proposal to the referenced contacts in item #2 below. Prior to any public hearing on this proposal a notification of the time and place of the public hearing will be sent to the adjacent property owners by the El Paso County Planning Department. At that time you will be given the El Paso County contact information, the file number and an opportunity to respond either for, against or expressing no opinion in writing or in person at the public hearing for this proposal.

3. The project is located at 8579 Eastonville Road, Peyton, CO on 1.5 acres, zoned RR5 for a school/church.
4. Liberty Tree Academy (LTA) is a Hillsdale College affiliate (tuition free) charter school that will open in August of this year in grades K-8 in a temporary location. We are in the process of purchasing the property on the attached map to build a Kindergarten through 12th grade school. Forty families and nearly 80 children of your immediate neighbors have already applied for enrollment in LTA.

We are in the process of designing phase I to begin construction this summer and intend to add an additional phase II at a later date that will then accommodate all grades, K-12. The initial phase includes classrooms for 450 students. When the second phase is completed it will house a total of only 702 students in all grades. The school is designed to be small enough to foster a family atmosphere for our neighbors in this part of our community. LTA will offer a Traditional American Education in a respectful, orderly environment.

5. The school being proposed is shown on the attached drawings. There will be one 2-story building approximately 34,500 square feet in size in Phase I and an additional 11,700 square feet in Phase II added on in future construction. Aside from classrooms, there are playgrounds, a parking lot, and multi-use gym/cafeteria/performance auditorium.
6. There are no waiver requests being made in the application to El Paso County as the current zoning allows for the school to be built on this location.
7. A Vicinity Map showing adjacent property owners is attached.






ADJACENT NEIGHBOR MAP




