Hi Nina,

I have actually taken apart some of the pages and transferred to Word - they appear to have an underlying Times New Roman Size 12 font but was working with the March 26th draft, not April 28 or any more recent changes since May 5.

I know what has been changed in Chapter 14 since the Mar. 26th draft with the first version of Chapter 14. Some is quite significant. SO asking if you have this material in a WORD format? and could send it to me.

It is difficult to examine/evaluate the 300+ Specific Strategies and 127 Objectives in the current format, so I am trying to classify the Specific Strategies within their groups and relative to the Objectives for the Goals they are within so I can see what is duplicated, missing or perhaps should be in a different category.

At his point each set of SS's has zero to four "Priorities" - but other than that are like alphabet soup.

So i am trying to do a stepwise analysis to see how these all relate - and I think each item (whether a Goal, Objective or SS) needs to have a unique identifier related to Chapter Number, Goals Number, Objective Number and Specific strategy Number -otherwise this document is doing to be VERY cumbersome and difficult to use. Just referencing pages will not work well even if only for "source of idea", let alone for referencing for presentations. At least under "old system" every plan item had a Goal, Policy and Action code (Just like the LDC).

Also there are 13 "Topical Chapters" - but in Chapter 14 the Chapter Numbers are not used for the Topics that go with Core Principles - which mostly match the 11 Topics released in March 9 draft , and the material from Topical Chapters 7 (Community Facilities - Schools and Public Safety) and Chapter 8 (Infrastructure other than roads) are condensed into "Community Facilities" which makes this a nutso Implementation Chapter. The water piece (CFI4) alone has 50 Specific strategies. It needs its own Topical Chapter and Implementation scheme.

I think there should be 12 Topical Chapters (Water/Wastewater should be by itself (just like Transportation - they are both the most complicated and difficult "infrastructure") in the first part of the Document (14all together including Intro and Vision). Water could be separated out of Chapter 8.

Current Implementation Chapter 14 (would become Chapter 15 if Water/Wastewater were split out as its own topic. The Implementation Chapter should have Categories that MATCH THE TOPICAL CHAPTERS. At this point they do not because there are Chapters 7 & 8 in the Topical Chapters which makes 11 Topics, but only 10 Topic categories (Community Facilities- no Infrastructure) in Chapter 14.

It appears that perhaps two departments at HLA were not communicating. It doesn't make any logical sense not to number the Core Principles and their accompanying topics to match the first 11 Topical Chapters.

So can you send me a WORD (preferbly WORD 97) version of at least Chapter 14.If you have the whole Plan as WORD that would be OK too.

I am wanting to deal here with the organization - not the word level editing. i.e just need something to cut and paste that would be useful to you.
