To Whom It May Concern:

Mountain View Electric Association, Inc. (MVEA) will be constructing a 12.5 kV underground electrical distribution feeder line running along the east side of Vollmer Road.

The underground installation will be approximately 1.75 miles in length and will begin at the intersection of Poco Road and Vollmer Road.

The installation will travel south along the east side Vollmer Road outside of the county right-of-way and will be done by open cut excavation within a 20' private easement. When the installation arrives at the proposed Briargate Parkway, installation will switch to directional bore for the road crossing. The installation will then travel along Briargate Parkway via open cut excavation, within another 20' private easement, until it arrives at the intersection of Briargate Parkway and Wheatland Drive. Here directional bore will be used again for the road crossings. Once the installation has crossed Wheatland Drive, it will be installed by open cut excavation along the southeast side of Wheatland Drive within a 20' private easement.

The majority of the site which will be disturbed currently consists of undeveloped land. The rest of the site consists mostly of bare earth that has been disturbed for residential development. The total area of land disturbance will be approximately 2.23 acres. Adjacent properties will not be affected.

Construction will primarily be completed within private easements. For the road crossings located within the county right-of-way, permit applications will be submitted to the El Paso County Department of Public Works.




