So long as the two permits operate within the amended replacement plan (3.0 AF for two lots from two wells) then there should be a finding of sufficient water supply. It looks like we want to split that amount in half so that each lot gets 1.5 annual AF, so revising the report to clearly identify the uses and amount on each lot looks like the best way to go.

Emilie and Andrea,

The first comment regarding amount of irrigation for lot 2 is an error in the spreadsheet which I can fix pretty easily on my end.

The other piece which I could use your input on, Andrea, is item #2 regarding the demand in excess of the existing well. Right now the existing well is permitted for 1.5 AF and is located on the larger lot #1. Currently, your augmentation plan is approved to cover 3.0 AF/year. In my report I split the demand relatively pro-rated in conjunction with the allotted acreage. Thus, I came up with 2.12 AF/year on lot #1 and 0.88 on lot #2. However, if we are confined to the amount of water currently permitted in the existing well, then I will need to dial back the demand to 1.5 AF/year rather than the potential 2.12 AF/year I currently have in the water supply report.

Anyway, I can certainly bump the demand in lot #2 back up to 1.5 AF/year so that we maximize the augmentation plan. But before I do that I wanted to make sure that it was OK to dial back the demand in lot #1.
