PROJECT DESCRIPTION

The applicant is requesting to amend the Rollin Ridge Filing No. 1 Final Plat, Lots 2 and 3 that would remove the 30 foot wide detention pond maintenance road access easement located between Lots 2 and 3, Rolling Ridge Filing No. 1 as illustrated on page 2 of the proposed amended Final Plat.

The applicant is also requesting a modification to Plat Note No. 16. Said revised Note to read:

“16. No driveway shall be established unless an access permit has been granted by El Paso County. Individual lot purchasers are responsible for constructing driveways, including necessary drainage culverts from Bark Tree Trail and Cherry Crossing Drive per Land Development Code Section 6.3.3.C.2 and 6.3.3.C.3. There shall be no direct lot access to Hodgen Road and State Highway 83, except for maintenance access to the drainage and detention Pond Easement in the northwest Corner of Lot 3 and the northwest corner of Lot 2 for pond maintenance purposes, from a point on Hodgen Road near the northwesterly corner of Lot 2.”
