PERMIT TO USE AN EXISTING WELL

ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT
CONDITIONS OF APPROVAL

- 1) This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of this permit does not ensure that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- 2) The construction of this well shall be in compliance with the Water Well Construction Rules 2 CCR 402-2, unless approval of a variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 18.
- 3) Approved pursuant to CRS 37-90-137(4) on the condition that this well is operated in accordance with the augmentation plan approved in consolidated case Nos. 18CW3077 (Division 1), and 18CW3035 (Division 2). If the well is not operated in accordance with the terms of said decree, it will be subject to administration including orders to cease diverting water.
- 4) The use of ground water from this well is limited to a combination of household use, irrigation of lawn and garden, greenhouse irrigation, equipment and structure washing, and the watering of horses, chickens, or equivalent livestock.
- 5) Approved for the change of use of an existing well constructed under permit no. 83350-A. The issuance of this permit hereby cancels permit no. 83350-A.
- 6) The entire length of the hole shall be geophysically logged as required by Rule 9 of the Statewide Nontributary Ground Water Rules prior to installing casing.
- 7) The pumping rate of this well shall not exceed 15 GPM.
- 8) **CONDITION REVOKED ON 08/26/2019 REPLACED BY CONDITION #9.**
 The annual withdrawal of ground water from this well shall not exceed 1.20 acre-feet.
- 9) The average annual amount of ground water to be withdrawn shall not exceed 0.6 acre-feet (as requested).
- 10) The allowed average annual amount of ground water to be withdrawn by this well in combination with other wells constructed in the Dawson aquifer and operating pursuant to the decreed augmentation plan in consolidated case nos. 18CW3077 (Division 1), and 18CW3035 (Division 2) shall not exceed 1.20 acre-feet.
- 11) The total depth of the well shall not exceed 940 feet, which corresponds to the base of the Upper Dawson aquifer. At a minimum, plain casing shall be installed and grouted through all unconsolidated materials and shall extend a minimum of ten feet into the bedrock formation to prevent production from other zones.
- 12) The owner shall mark the well in a conspicuous location with well permit number(s), name of the aquifer, and court case number(s) as appropriate. The owner shall take necessary means and precautions to preserve these markings.
- 13) A totalizing flow meter must be installed on this well and maintained in good working order. Permanent records of all diversions must be maintained by the well owner (recorded at least annually) and submitted to the Division Engineer upon request.
- 14) **CONDITION REVOKED ON 08/26/2019 REPLACED BY CONDITION #16.**
 Pursuant to CRS 37-90-137(9)(b) and the Denver Basin Rules, no more than 98% of the nontributary ground water withdrawn annually shall be consumed and the well owner shall demonstrate to the reasonable satisfaction of the State Engineer that no more than 98% of the water withdrawn will be consumed.
