She seemed a bit relieved to know we were replacing the existing tower and not proposing a new structure and was going to discuss it with her husband that evening. She said she would call me back if she had any further questions or comments and I have not received a call back since.
- **LM Hillyer** - I placed a call on Wednesday, 11/29 at 3:10 pm and received voicemail where I left a brief explanation of our proposal and left my contact info in case someone wanted to call me back – I have not received a response.
- **Kelvin Mays** - I placed a call on Wednesday, 11/29 at 3:15 pm and again on 12/1 at 11:55 am. His voicemail was full both times.
- **Richard Stewart Jr.** - I placed a call on Wednesday, 11/29 at 3:15 pm and spoke to Mr. Stewart. He seemed a bit relieved when I explained that we are replacing the existing tower and not proposing a new structure. I recommended that he go look at the Sprint installation on the Falcon MS football field to get a better idea of what our installation will look like. He said he would call me back if he had any further questions or comments and I have not received a call back since.
- There was one letter that did not have a name or contact number so no action was taken

Falcon Middle School

- **Rebecca Bonilla** - I placed a call on Wednesday, 11/29 at 2:40 pm and spoke to Mrs. Bonilla. After I explained our proposal she said she is no longer in opposition.
